#### **Unfinished Business**

#### a) TFP1, Inc. dba Total Fire Protection

Complaint received 2/24/21 naming TFP1, Inc., dba Total Fire Protection. The location is Chili's Restaurant, 280 Pond Path, South Setauket, NY 11738. Motion to send Letter to Appear to both the Certificate of Registration holder and the technician named in the complaint made by J. Meyer and seconded by M. Matteo. 3/18/21.

- J. Capone, President, and technician G. Rodriguez were both in attendance. J. Capone addressed the issue with the tags stating they were not aware the address had to be printed on the tag, as other jurisdictions do not require this. He will have new tags made with all required information and will send a copy of said tag when they are received.
- J. Capone and G. Rodriguez discussed the issue from the complaint and stated that after receiving the complaint, they went back to address and correct the issue. G. Rodriguez spoke in length regarding how he serviced the system; they provided new pictures, invoices, and service reports as evidence of the correction for the Board to review.

Motion to have J. Capone send a letter of retraining of their technicians as well as a new tag with correct information on it to the Board. Motion made by M. Matteo and seconded D. Lynch.

### b) LC Squared dba All Out Fire

Complaint received 1/29/21 naming All Out Fire. The location is H.L. Dennison Building, 100 Veterans Highway, Hauppauge, NY 11788. Motion to send Letter to Appear made by M. Matteo and seconded by A. Duspiva. 3/18/21. Certified Letter sent, no correspondence received.

R. LaVacca present at the meeting. He stated to the Board that his technician should have replaced the extinguishers himself rather than having the building maintenance personnel be responsible. After receiving the complaint, he spoke with his staff to reeducate and retrain.

Motion to have a Letter of Retraining sent to the Board made by D. Lynch and seconded by A. Duspiva.

#### c) Life Safety Fire & Security Solutions

Complaint received 2/4/21 naming Life Safety Fire & Security Solutions. The location is American Tire Distributors, 121 Wilshire Blvd, Edgewood, NY 11717. Motion made to send Cease and Desist letter made by M. Matteo and seconded by J. Meyer. 3/18/21. Certified letter sent; received an email back from Robert Vezina, President of Life Safety Engineered Systems, Inc.

Letter from R. Vezina read to the Board, stating that Life Safety has never working in any capacity for American Tire and that Life Safety also sold off all of its service teams in March of 2020; they have no technicians of any kind at this time. He believes it is possible that an ex-employee sold the tags to someone who is fraudulently performing service or that American Tire bought tags and is performing the service fraudulently themselves. He asked that we keep him information as to what happens and if any further information is needed, to please contact him.

Motion is made to forward this issue to Legal and follow up with the DA office made by M. Matteo and seconded by D. Lynch.

#### d) National Fire and Safety Solutions, Inc.

Complaint (correct form) received 3/24/21 naming National Fire and Safety Solutions, Inc. The location is Speedcast, 45 Oser Avenue, Hauppauge, NY 11788. Motion made to table until follow up is complete made by J. Meyer and seconded by A. Duspiva. Correct complaint form received from FM Raia. 3/24/21

Motion to send letter reminding of the Suffolk County Rules and Regulations as to what is needed to appear on all tags in order for them to be compliant, along with an example of a compliant tag for their reference. Motion made by D. Lynch and seconded by J. Meyer.
