1. License

The County of Suffolk, acting through its Office of the Suffolk County Clerk (the “Licensor”), grants to the duly authorized holder (the “Licensee”) a non-exclusive, non-transferable personal limited license (the “License”) to access on the Internet certain databases maintained by the Licensor in its Online Records System in order to obtain copies of the following (collectively, the “Licensed Data”) subject to the terms and conditions described herein.

3. License Terms and Conditions

Licensee shall use the Licensed Data only in a lawful manner and in accordance with all applicable federal, state and local laws, rules and regulations. Licensee represents and warrants that it has and will continue to have in place policies and procedures that will protect the security of all Licensed Data in its possession. Licensee hereby consents to the Licensor's periodic audits of and investigations into Licensee's use and dissemination of the Licensed Data. Such audits and investigations may be conducted without notice, at County's sole discretion. The Online Records System may not be mined and the Licensed Data may not be sold or used in any pay-for-use application without first obtaining the County's express written permission. Access to the Online Records System by any automated program (e.g. bots, crawlers or spiders) for the purpose of extracting data for any use whatsoever is prohibited. The dissemination, transmission or use of licensed data and or images for any commercial purpose is prohibited.
