RESIDENT, JR., SENIOR CITIZEN, HANDICAPPED GREEN KEY– Valid for three years from date of purchase. Suffolk County residents/property owners must provide two forms of proof of residency, one proof must be a photo I.D. (driver’s license) with a physical address. If non-Suffolk County or P.O. Box address, two additional proofs required. Additional proofs can be any of the following: Suffolk County property tax bill, property deed (dated less than 6 months), utility bill, a Suffolk County voter’s registration card, vehicle registration, library card, or an official residential lease for a minimum of nine months with same address as photo I.D. Post Office boxes are not accepted as proof of residency. Resident senior citizens (60 and over) will receive discounted rates as indicated with proper I.D. To receive handicapped discount green key, applicant must be a Suffolk County resident with above residency proof and show either a New York State Parks Access Pass or S.C. Handicapped I.D. card (yellow photo I.D.) issued by Suffolk County Office of Handicapped Services. Handicapped parking permits are not accepted as proof of handicapped status. **ALL PROOFS MUST BE CURRENT, NOT EXPIRED.**

VOLUNTEER FIRE FIGHTER, EMT, C.E.R.T.\* & AUXILIARY POLICE GREEN KEY – Valid for three years from date of purchase. Suffolk County resident volunteer fire fighters, ambulance personnel & auxiliary police will be charged senior citizen rates for park fees (excluding golf). Residency requirements as listed above. C.E.R.T (\*Community Emergency Response Team) volunteer must provide valid S.C. C.E.R.T. Team Member photo I.D. card with expiration date. Auxiliary Police I.D. required. Firefighter/EMT identification card with a valid expiration date, or a letter on official stationary, dated within one year of date of purchase from their fire department/ambulance company/police department.

VETERAN GREEN KEY – Valid for three years from date of purchase. Suffolk County resident Veterans will be charged senior citizen rates for park fees (excluding marina fees). Must submit DD Form 214 (Certificate of Release or Discharge from Active Duty) or a Suffolk County Resident Veteran I.D. Card.

**DISABLED VETERAN GREEN KEY (FREE)** – Valid for three years. Residency requirements as above. Suffolk County residents with V.A. Identification Card stating “Service Connected” disability are exempt from fees **EXCEPT GOLF FEES (INCLUDING RESERVATION AND PENALTY FEES), CAMPING AND MARINA FEES (INCLUDING RESERVATION, PENALTY FEES, LOCATION AND UTILITY FEES), AND CONTRACT FEES.**

**ACTIVE MILITARY EXEMPT GREEN KEY (FREE)** – Families of Suffolk County residents who are actively deployed or mobilized (more than two week duty), or members of the armed forces who are on “ACTIVE DUTY” and a resident or stationed in Suffolk County are exempt from paying park daily fees **EXCEPT GOLF FEES (INCLUDING RESERVATION AND PENALTY FEES), CAMPING AND MARINA FEES (INCLUDING RESERVATION, PENALTY FEES, LOCATION AND UTILITY FEES), AND CONTRACT FEES.** Military I.D. card, mobilization and/or deployment orders, orders of assignment, or currently dated letter from commanding officer stating that applicant is a currently active member of the armed forces, and Suffolk County residency requirements listed on Page 1 are needed to obtain an exempt Military Green Key Card (valid and renewable at the end of each calendar year). **Available at Parks Operations Office in West Sayville only.**

**NON-RESIDENT RESERVATION KEY** - Allows non-residents access to golf and camping reservation system on a limited basis, non-resident rates apply. Valid for one year from date of purchase.

**NON-RESIDENT GREEN KEY** – Allows non-residents or seasonal residents to make reservations and receive resident rates for permits and park activities.
