Historic Trust Docket:

Director's Report:

- Updates on Housing Program for Historic Trust Sites

Mr. Martin noted that they have one vacancy at River Road in Manorville which the interior will be fixed up by the Parks Department staff and then be ready for a new tenant. That is the only vacancy they have at this time.

We had a vacancy at the Isaac Mills house which was recently occupied they were concerned because it is a stand-alone park with no supervisor. They had a Suffolk County Police Office moved into the site.

Inland Pond known as the Red House on Sound Avenue in Greenport we have an apartment on the 2nd floor and the Audubon office is on the first floor. We had a Suffolk County Police Office took the apartment on second floor.

- Updates on Historic Trust Custodial Agreements

Mr. Martin noted that on the Lads Report IR number 1634 is the custodial agreement with the Farmingville Historical Society. We have been in contract and have worked with this group for over 30 years. The Historical Society will be helping with the rebuild for the School House on Terry House. Contract is going forward.

A presentation regarding the proposed improvements to Cathedral Pines County Park was given at the meeting by Kenneth Phalen, Assistant County Architect, and Suffolk County Department of Public Works. At the last CEQ meeting after the project discussion, the CEQ decided to table the proposed action and request that the Suffolk County Department of Public Works provide the CEQ with the related Cathedral Pines Master Plan.

Mr. Phalen, supplied the Master Plan which was distributed to CEQ. The project involves a comprehensive Analysis for the park for future improvements that would also help to increase revenue. The project will include a new park Maintenance Facility, a new campground Check-in Station, a new bathroom facility, upgraded utilities, improved camp site layout with added utilities, improved recreational facilities,

After the discussion Ms. Kepert made a motion to recommend classification of the proposed project as a Type I Action with a Negative Declaration. The motion was seconded by Mr. De Rubeis. Motion carried
