2	THE CHAIRPERSON: I'd like to call the
3	meeting to order. Any correspondence that
4	you want to call to our attention, Jim?
5	MR. BAGG: No. Nothing received as of
6	the meeting.
7	THE CHAIRPERSON: Okay. I'd like to
8	remind everybody that this is a public
9	meeting. You will be provided with the
10	opportunity to speak.
11	Generally we'll give you that
12	opportunity when the particular topic shows
13	up. And for probably the airport discussion,
14	I would like to recommend that you give us a
15	list of who would like to speak so that we
16	can determine how long each individual should
17	be allowed to talk.
18	MR. POTENTE: Mr. Chairman, may I just
19	make a note on the minutes?
20	THE CHAIRPERSON: Yes.
21	MR. POTENTE: Regardless of what is
22	going on, I would like to make a
23	recommendation that we receive the minutes in
24	a more timely manner. I have looked at the
25	minutes.

2	When I look at the minutes it's a couple
3	of months late. That's for two reasons.
4	Number one, in order for us to verify
5	that the minutes are indeed correct, we
6	should have them sooner. One month I think
7	is an adequate amount of time between
8	meetings in order to have the minutes.
9	Number two, for many of these issues we
10	want to double check or verify that certain
1.1	issues are correct or not. We need the
12	minutes on hand before a recommendation goes
13	to the legislature.
14	For that reason I also think that the
15	minutes should be at least no more than one
16	month.
17	THE CHAIRPERSON: Thank you, John.
L8	I agree with you. I am not sure whether we
L9	are going to solve that problem as long as
20	they have verbatim minutes. We used to get
21	the minutes instantaneously.
22	MR. POTENTE: I understand.
23	MS. STILES: Larry, to solve the
4	problem, we could have a taperecording that
5	is easily reproduced. We need to know

2	exactly what was said quickly.
3	So that gives us adequate time to type
4	it up. Because there have been times when we
5	need to know exactly what was said.
6	So I don't think that going back to the
7	old way would help. It's just an idea. I
8	think that it would be very helpful.
9	MR. BAGG: We used to type the minutes
10	and have that available and have the minutes
11	pursuant to Robert's Rules of Order which is
12	simply a summary of business transacted.
13	And the taperecorder was available of
14	the meeting if necessary for anything
15	verbatim in case of a lawsuit or something
16	else of that nature.
17	THE CHAIRPERSON: But we are not doing
18	that now.
L9	MR. BAGG: No.
20	THE CHAIRPERSON: Maybe we can talk
21	about that problem. Okay, recommended type
22	two actions. Jim, do you have any comments
23	that you want to call to our attention?
24	MR. BAGG: No. The package is pretty
15	straightforward. It should be noted in the

2	packet that there were two findings,
3	statements on the VECTA control, long term
4	wetland management plan and VECTA control.
5	One was submitted by the County
6	Executive's office. One was submitted by
7	Legislator Fischer.
8	It's also in that packet, a resolution
9	forming the wetlands strategy, committee and
10	funding for that committee as a follow up to
11	the recommendations.
12	MS. SQUIRES: What number?
13	MR. BAGG: If you look in your packet.
14	I don't know offhand.
15	THE CHAIRPERSON: 1130, 1131 and 1150.
16	MS. STILES: Is there a way to make
L 7	copies? I received the findings statement
18	in my packet that was mailed home.
19	But I am not sure which one it was.
20	And I think that it might be helpful as we
21	go through it.
22	THE CHAIRPERSON: Okay.
23	MR. BAGG: Yes, I'll try to get them
24	and mail them out.
25	MS STILES. Thank you

2	MS. VILORIA-FISHER: Kara, could it be
3	possible to ask the clerk's office to just
4	provide them? Which ones did you receive?
5	MS. STILES: I'm not sure. It just
6	says findings statement.
7	MS. VILORIA-FISHER: Does it have an
8	attached resolution with it, Lauren?
9	I'm trying to remember. Kara, maybe the
10	clerk's office could give us. We don't
11	need that many copies.
12	MS. HAHN: Sure.
13	MS. VILORIA-FISHER: Would that be
14	okay, Mr. Chairman?
15	THE CHAIRPERSON: Yes, that would be
16	good.
17	MS. VILORIA-FISHER: Fine.
18	MR. KAUFMAN: I'll make a motion to
19	adopt the staff recommendations.
20	THE CHAIRPERSON: We have a motion to
21	adopt. Do we have a second?
22	MS. STILES: I'll second the request.
23	MR. KAUFMAN: We review the packet
24	from a point of view of what is required
25	under SEQRA. And if it's an unlisted or

2	a type one action, whether it's been
3	submitted to CEQ and whether it's passed CEQ
4	and now before the legislature in a final
5	version of SEQRA.
6	So in essence that findings statement
7	when adopted by the legislature will complete
8	it.
9	MS. STILES: I'm just curious why
10	they are here. What do you think our role
11	is in that? The reason that I'm bringing
12	this up is because I already spoke to you.
13	Some of the recommendations that were
14	sent to the legislators were not necessarily
15	exactly what we had voted on at the last
16	meeting.
17	And I just want to make sure. We don't
18	have the minutes yet from that meeting.
19	I just want to make sure that we are not
20	somehow, you know, awaiting the concern that
21	we don't have the recommendations exactly as
22	we voted on them.
23	MR. BAGG: The recommendations before
24	you in the packet are the findings statement

1

25

by the legislature that include all of the

2	environmental recommendations including CEQ's
3	request which is only part of the
4	environmental review.
5	MS. STILES: Right.
6	MR. BAGG: And it also includes social
7	and economic policy decisions by the
8	legislature with respect to the entire
9	program.
10	So in essence those resolutions complete
11	SEQRA. I mean, it's debatable whether or not
12	you don't think what was said across the
13	street by CEQ was totally accurate.
14	MS. STILES: What I am stating is,
15	I mean the findings statement that I reviewed
16	said that it was based on the recommendations
17	and other things, you know, the
18	recommendations from SEQRA, comments from
19	SEQRA and the public.
20	What I am saying is that the legislature
21	didn't have the actual recommendations from
22	the CEQ because they weren't fully accurate.
23	So I am not sure how anyone could be
24	voting on the findings statement without
15	having the actual, they can ignore the

2	recommendations if they want to.
3	But they have to have them if they are
4	not a hundred percent accurate. And I think
5	that we need the minutes to make sure that
6	they are.
7	THE CHAIRPERSON: Legislator Viloria-
8	Fisher.
9	MS. VILORIA-FISHER: Actually the
10	legislator didn't act on the recommendations
11	from CEQ. And we have not yet acted on the
12	other recommendations.
13	The recommendations from CEQ as far as
14	can see were accurate as they were presented
15	to the legislator, to the environmental
16	community.
17	And there was testimony there from the
18	members of CEQ, some members of CEQ and some
19	members of the public that were there.
20	As far as I could see, it was a
21	representation of the recommendations that we
22	voted on. I think that Jim Bagg and his
23	department, his staff worked very hard on
24	trying to reflect the feeling of CEQ and the
:5	findings of CEQ.

2	As far as the findings statement that
3	you have, the reason that there are two is
4	that the findings were done by an executive
5	staff.
6	And I didn't feel that, well I certainly
7	didn't agree with that being the old findings
8	that should come before the legislature.
9	And so I introduced another resolution
10	to include the parts of the recommendations.
11	And that's why it has my name on it as a
12	member of CEQ.
13	But indeed what did come before us as
14	the environmental committee, I believe, was
15	very, very true to what we have discussed in
16	CEQ. And the Environmental Committee didn't
17	act upon it.
18	MS. STILES: I am not saying that they
19	have to act upon it.
20	MS. VILORIA-FISHER: Well that's not
21	before us then.
22	MS. STILES: What I am saying is that
23	procedurally under SEQRA, under the county
24	charter, the legislature has to have our
25	recommendations before them. They can ignore

7	
2	it.
3	MS. VILORIA-FISHER: They did.
4	MS. STILES: What I am saying is that
5	those recommendations that were sent over
6	to you were not a hundred percent accurate.
7	MS. VILORIA-FISHER: Well I disagree
8	with you. I think they were accurate.
9	MS. STILES: I think that the
10	appropriate thing to do would be to get a
11	copy of the minutes to clarify. It might
12	just be the one that I need. But there might
13	be other things too.
14	I spoke to Jim about it when I first
15	received a copy of the recommendations. The
16	one issue that I noticed was that on the
17	adult deciding threshold, the recommendations
18	that were presented to the legislature said
19	that it should be, the threshold should be
20	reviewed.
21	But I distinctly recall making that
22	motion at the CEQ meeting. And it said that
23	the threshold should be reviewed and an
24	arbitrary stricter standard should be used.
25	So that's different. And I think that

1	
2	the CEQ, I mean the legislature can ignore
3	that if they want to.
4	But procedurally under SEQRA if the
5	legislature is going to move forward without
6	having the actual recommendations, that's
7	asking for trouble.
8	MS. VILORIA-FISHER: But the legislature
9	did not move forward on those
10	recommendations. We did not act upon them
11	and they are not before us. Is that
12	procedurally correct, Jim?
13	The findings were not prepared by the
14	legislature. The findings were prepared by
15	the executive office.
16	MR. KAUFMAN: May I break in for a
17	second?
18	MS. VILORIA-FISHER: Procedurally we
19	are not going on what the legislature
20	has done based on CEQ's recommendations.
21	MR. KAUFMAN: There are several things
22	going on here. One, we are not voting on
23	procedure aspects.
24	There is no prejudice to any substantive
25	comments that you have or anything like that



1	
2	that you want to bring before the
3	legislature, et cetera.
4	Secondly, these are the findings
5	statement as the legislature just said.
6	These were prepared by County staff.
7	The County Executive has submitted them
8	in the format of a bill. Our recommendations
9	and the ones that you are questioning were
10	considered, were apparently heard. I mean,
11	we know that the County staff was there at
12	the CEQ meeting.
13	MS. STILES: They didn't have the
14	correct recommendations.
15	MR. KAUFMAN: No, this is different.
16	The recommendations are different from the
17	findings statement.
18	MS. STILES: I understand that.
19	MR. KAUFMAN: And there are basically
20	two competing bills out there.
21	THE CHAIRPERSON: Lauren, I think that
22	Jim did a superb job reflecting what went on
23	at a very complex meeting.
24	I think that your opportunity if you
25	disagree is that when the legislature, the

2	full legislature I guess has their public
3	meeting that you express your opinion there.
4	As far as I am concerned, as Chair of
5	this meeting, this is over and done with. I
6	think there is no point in wasting any more
7	time on it.
8	And I think, there were several things
9	in the findings quite frankly that I thought
10	were wrong. But overall
11	MS. STILES: I'm not saying that it's
12	wrong in terms of I disagree with them. I'm
13	saying wrong in terms of it's not accurately
14	reflecting what we voted on.
15	There were plenty of things in there
16	that I disagree with. But if we voted on it
17	as a majority, then that's what should go
18	over to the legislature.
19	THE CHAIRPERSON: You have an
20	opportunity to express yourself if you feel
21	that there were not proper representation.
22	And I don't know when that will come up, next
23	month or the month after.
24	MS. STILES: I was thinking that perhaps
25	the CEQ that made their recommendations would

2	be concerned that it's recommendations were
3	not accurately reflected.
4	THE CHAIRPERSON: I don't think that the
5	CEQ wants to go back there again. Because I
6	think quite frankly that you might not get
7	the results you want.
8	MR. POTENTE: Mr. Chairman, as far as I
9	am concerned, the issues have been adopted.
10	The point that Lauren is bringing up is that
11	they want it accurately depicted in the
12	transcript for the legislature.
13	I don't think that it's a big issue.
14	But I do think that the CEQ owes her, owes
15	itself an accurate depiction of actually what
16	transpired.
17	At some point I think that any minor
18	discrepancies should be resolved by the CEQ.
19	I don't think that we have to have a full
20	blown forum over it. It's just a matter of
21	coordinating.
22	THE CHAIRPERSON: I'm not sure that I
23	want to go there. Anyway there is now a
24	motion that has been made.
25	MS. VILORIA-FISHER: I'll second it.
	•

1	
2	THE CHAIRPERSON: We have a second.
3	All in favor?
. 4	(Aye.)
5	THE CHAIRPERSON: Opposed?
6	MS. STILES: Yes.
7	THE CHAIRPERSON: Abstention?
8	MR. POTENTE: I'm opposed.
9	THE CHAIRPERSON: Three to two.
10	Mary Ann?
11	MS. SPENCER: In favor.
12	MR. POTENTE: I'm opposed.
13	MS. VILORIA-FISHER: Approve.
14	MR. KAUFMAN: I'm in favor.
15	THE CHAIRPERSON: Approve. So it's
16	four-two. I am going to adjust the agenda
17	and put item number two, the proposed
18	redevelopment of Long Island Jet East, Inc.,
19	Francis Gabreski Airport in the Town of
20	Southampton, to the end of the meeting. I
21	think that there's going to be a lot of
22	public comment.
23	And I want to move ahead and get some of
24	these other actions taken care of. So let's
25	start with proposed aquisition of land for

2	open space preservation.
3	MS. FISCHER: Loretta Fischer, Suffolk
4	County Planning Department. The first one
5	before you today is an acquisition along
6	Doxsee's Creek to add to our holdings in this
7	area in Islip.
8	This is a tributary creek that flows
9	into Great South Bay. It's two and-a-half
10	acres adjacent to other parcels that we're
11	looking to acquire at least part of and
12	within a close proximity of other County and
13	Town of Islip property along this corridor.
14	MR. KAUFMAN: If I remember correctly,
15	I think you said a number of properties in
16	this area. Is there anything to the south
17	of here?
18	MS. FISCHER: Oh yes, absolutely.
19	This is just a highlight of this second
20	portion of the property.
21	MR. KAUFMAN: I think I remember there
22	being something to the north of here.
23	MS. FISCHER: Yes, north and south.
24	MR. KAUFMAN: This is just building
25	a chain?

1	
2	MS. FISCHER: Yes.
3	MR. KAUFMAN: I'll make a motion for
4	a neg dec.
5	THE CHAIRPERSON: Do we have a
6	second? I have a question. Is this a
7	purchase price?
8	MS. FISCHER: We have been requested
9	by law to redact that information. It's
10	privileged if the resolution is laid on the
11	table for a copy of the resolution that you
1.2	had before you as a draft.
13	MR. KAUFMAN: Second.
14	THE CHAIRPERSON: All in favor?
15	(Unanimous aye.)
16	THE CHAIRPERSON: Opposed?
17	(None.)
18	THE CHAIRPERSON: Motion carried.
L9	MS. FISCHER: The second item on your
20	agenda is the acquisition of the property
21	in Mastic-Shirley, the Froehlich property.
22	This is a piece of property .089 acres
23	in our, again Mastic-Shirley is adjacent to
:4	two other County holdings in an area that we

We have a state law to deal with passed in the year 2004 which describes the various stipulations which we will follow in terms of how we will craft the specifics of this program.

Suffice it to say that much of this particular area will not be subject to any sort of leasing activity.

We have to take into consideration many factors, existing uses, environmental considerations, et cetera, to reduce the area that will be eligible for leasing when we define a shellfish cultivation zone in the Peconic and Gardiners Bays region.

This is a project that will take approximately a little over a year and-a-half to complete. It is conducting some of the technical aspects of the project.

The County Executive established a lease program advisory committee with 17 members.

And they have been meeting and will continue to meet to review the products that are produced by the staff and the consultant as

2	the project continues.
3	So in terms of where we are on short
4	term, we will have a scoping document
5	prepared. And we will proceed with the
6	discussion of that at the meeting that is
7	scheduled at this point for March 22nd, the
8	notices of which will be sent shortly from
9	the office.
10	So if anyone has any particular
11	questions about the project, we would be
12	happy to answer them.
13	THE CHAIRPERSON: Thank you.
14	MR. KAUFMAN: I have a technical
15	question. I am looking at the covering

3	entirety.
4	MR. KAUFMAN: So then basically you
5	are saying GEIS plus master plan and then
6	individual inside the context of a master
7	planning process you will be looking at
8	individual areas and seeing whether they can
9	support shellfish habitat, whether they
10	can't, et cetera?
11	MR. DAVIES: Yes.
12	MR. KAUFMAN: So you don't have a
13	problem if we want to go that way?
14	MR. DAVIES: Well master plan, it
15	is analogous to the preparation of a master
16	plan because of the steps that we have to
17	take.
18	When we establish an aquaculture zone,
19	it's analogous to the process that would be
20	used to establish a zoning code in an upland
21	setting.
22	Although in this case we are dealing
23	with a seascape. We are not necessarily
24	looking at areas that could be zoned for
25	other kinds of uses.

2	It is not a comprehensive look at the	:
3	entire system with respect to how other ar	eas
4	can be zoned or maybe zoned in the future.	
5	MR. KAUFMAN: In which case if I am	
6	hearing you correctly, you are saying that	a
7	master plan aspect may not be the best way	
8	for you to proceed.	
9	You may like to do it just as a GEIS	
10	without the master plan component. Is tha	.t
11	what you are saying?	
12	MR. DAVIES: I am not quite sure what	
13	you are referring to.	
14	MR. KAUFMAN: To use some forbidden	
15	plan. When the VECTA control plan and VEC	TA
16	control issue was before us back in 2002,	
17	this Council decided/recommended that a GE	IS
18	be undertaken and also a master plan be	
19	implemented for the GEIS.	
20	That was the most efficient way of do	ing
21	things as far as we saw at that time in te	rms
22	of basically establishing the environmenta	1
23	setting, establishing the environmental	
24	limits and then having a plan set forth tha	at
25	could be analyzed.	

2	In terms of the GEIS master plan, it's
3	usually the best way to go as companion to
4	the GEIS. You can go without it, I believe.
5	There are certain restrictions within
6	SEQRA when you do that. But it is usually
7	better to use a master plan, whatever plan
8	you come up with.
9	And that is what I am trying to focus in
10	on, which way do you want to go.
11	MR. DAVIES: Okay. The program will
12	result in, if you want to use the term
13	"master plan", I wouldn't use that for this
14	particular project.
15	But we will be developing a recommended
16	program for implementation which will involve
17	this particular activity.
18	So it will involve the administrative
19	components. If you consider that a master
20	plan, I can understand that.
21	MR. KAUFMAN: You said recommended
22	aspects of that. GEIS is the right way to
23	go. If you don't want to go there, you don't
24	need to have a master plan. You set up the
25	GEIS in your plan.

1	
2	MR. BAGG: If I might say, you can have
3	a GEIS on a number of things. It doesn't
4	have to be the master plan.
5	It can be a program to lease shellfish
6	areas under the jurisdiction of New York
7	State. And GEIS is done on a program.
8	MR. KAUFMAN: That's why I'm saying it's
9	okay with me.
10	THE CHAIRPERSON: Legislator Viloria-
11	Fisher.
12	MS. VILORIA-FISHER: I attended as you
13	said that public hearing. And my question
14	doesn't go to the environmental impact but
15	the social economic impact that would be
16	borne by the members of the public at that
17	meeting.
18	And one of the things that I felt
19	compelling were these small business people
20	who are interested in a program that it not
21	go to large corporations that would wind up
22	as a result of this being owners of large
23	parts of waters.

2	before us here? At what point in the process
3	will we vote on that part of the program?
4	MR. DAVIES: There are basically two
5	parts of this program. One is the location
6	of where and the other is the question of
7	how.
8	The locational aspect that we will be
9	looking at is where the shellfish cultivation
10	lease zone would occur. Where will it be?
11	The administrative aspect of the program
12	will deal with how leases would be
13	structured, how they would be reviewed, how
14	they would be issued and how they would be
15	carried out.
16	So yes, the question about lease sizes
17	is a major concern I think of some people.
18	And you can address that by limiting the size
L9	that or the leased area that could be signed
20	over and of course in a shorter period of
21	time or whatever.
22	You can have five acre leases, ten acre
23	leases, et cetera. You could have limits on
2.4	the number of leases that could be secured by
.5	any individual. It could be up to one lease

1	
2	per person or company.
3	So there are a number of ways that that
4	issue can be addressed. And we are well
5	aware of that.
6	And one of the reasons why the State law
7	was changed in 2004 was to repeal an older
8	State law which had other stipulations in it
9	with respect to leasing which were not
10	concerned so much with the size of the lease.
11	So we are very aware of that problem.
12	And it will be addressed and again there are
13	a number of ways that we can do that in the
14	administrative aspects of the project, yes.
15	MS. VILORIA-FISHER: Thank you.
16	THE CHAIRPERSON: Do we have any other
17	questions?
18	MS. STILES: The 100,000 acres, does
19	that include all underwater acreage between
20	Riverhead and the line out east? It looks
21	on the map like the entire bay bottom.
22	MR. DAVIES: Okay.
23	MS. STILES: And I think that there are
24	some privately owned people that have leasing
25	rights.

2	MR. DAVIES: If you look at the aerial
3	photo there, we are not looking at all at
4	any trees to control lands in the townships.
5	These are all the local canals and what
6	have you. That is not within the purview of
7	our program.
8	The purview of our program includes
9	State underwater lands which was ceded to
1,0	Suffolk County for the purpose of this
11	particular project.
12	And that included only the lands that we
13	see with regard to a thousand feet of high
14	water. So that's what that white line on the
15	map shows you.
16	There are a number of parcels in the
17	Peconic Bay which were oyster grants that
18	were sold by Suffolk County to private
19	parties beginning in 2984.
20	We have about four or five such parcels
21	in place today. There are certain rights
22	associated with them.
23	And the individuals that own those
24	parcels can cultivate them as a matter of
25	right. If they fail to pay their real estate

2	taxes in a timely manner, they can be taken
3	by the County and many have.
4	We will be dealing with those particular
5	parcels inasmuch as they deal with only now
6	one species of shellfish which is the oyster.
7	We were looking at those parcels also
8	with the possibility of crafting a
9	recommended program where they could culture
10	other species of shellfish under a lease
11	agreement also.
12	So we will deal with them specifically
13	and separately in the program as we develop
14	them.
15	MS. VILORIA-FISHER: But I just want to
16	clarify something in response. Are you
L7	saying that the administrative portion will
L8	be part of the GEIS that will come before us?
L9	MR. DAVIES: Yes. Part of the whole
20	thing will be addressed during that process.
21	MS. VILORIA-FISHER: Thank you. I
22	just wanted to be clear on that.
23	THE CHAIRPERSON: Are there any other
2.4	questions? Jim?
2.5	MR. BAGG: Yes. I might point out

2	that the information handed out will be
3	a scoping process to the GEIS as well. And
4	people from the local community as well as
5	CEQ will be involved in that process which
6	will go to the legislature.
7	THE CHAIRPERSON: Thank you. I'll
8	take a motion.
9	MR. KAUFMAN: I'll make a motion that
10	this is a type one action with a positive
11	declaration and a recommendation that a
12	GEIS be prepared.
13	MS. VILORIA-FISHER: I'll second that.
14	THE CHAIRPERSON: We have a motion
15	and a second. All in favor?
16	(Unanimous aye.)
17·	THE CHAIRPERSON: Opposed?
18	(None.)
19	THE CHAIRPERSON: Motion carried. Thank
20	you.
21	MR. DAVIES: Thank you very much.
22	THE CHAIRPERSON: Proposed relocation
23	of the Suffolk County Police Department,
24	4th Precinct, Town of Smithtown.
25	MR. BORKOWSKI: Ralph Borkowski, Suffolk

2	County Department of Public Works. Is it
3	possible to put us off to later on in the
4	agenda? Our consultant is on his way. He
5	was delayed. That is to present the project
6	He said that he will be here by 10:30.
7	THE CHAIRPERSON: Okay. I'll be glad
8	to do that.
9	MR. BORKOWSKI: Thank you.
10	THE CHAIRPERSON: Proposed intersection
11	improvements on County Road 19, Furrows Road
12	in the Town of Islip.
13	MR. MACKEY: My name is Russ Mackey,
14	Suffolk County DPW. This is an intersection
15	improvement project CR 19, Patchogue-Holbrook
16	Road at Furrows Road.
17	With me to help me present this program
18	is Steve Normandin.
19	THE CHAIRPERSON: Excuse me. What is
20	the consultant group?
21	MR. NORMANDIN: RBA Group. I am here
22	to describe this project. It falls in the
23	Town of Islip in the intersection at CR 19,
24	Patchogue-Holbrook Road and Furrows Road.
25	Just to give you a little better tagte

T	
2	of where it is, Mama Lombardi's Restaurant
3	is in the southwest corner.
4	This project is brought by Suffolk
5	County to improve the traffic operations
6	at this intersection. Currently there is
7	high congestion and safety concerns at the
8	intersection.
9	And what we are proposing is to widen
10	the approaches on both Furrows Road on the
11	east and west as they approach up to
12	CR 19.
13	As it currently exists, the traffic
14	backs up from CR 19 west to Main Street.
15	There is a queuing problem there as well
16	as on the opposite east approach and some
17	queuing problems on CR 19 as well trying to
18	make a left turn onto Furrows Road.
19	The existing condition, there is a
20	through and a left lane in both directions.
21	We are proposing a through and a right
22	and a left turn lane. So widening of one
23	lane on each approach to store the cars and
24	to improve the signal operations.
25	What the project involves is the

2	new curb resurfacing of the pavement,
3	widening of approximately five feet on
4	either side of the road and a new drainage
5	structure and a brand new traffic signal
6	with pedestrian signals.
7	We have a new crosswalk which doesn't
8	exist at this moment. I'll take any
9	questions.
10	THE CHAIRPERSON: Go ahead.
11	MR. KAUFMAN: Basically this road and
12	these expansions are going to be built within
13	the existing right of way except for some
14	small takings if I understand correctly?
15	MR. NORMANDIN: That's correct. The
16	same takings at the property are about five
17	feet wide and 120 feet in length.
18	It would be commercial property on the
19	north side, similar strip taking and a small
20	residential taking on the northeast corner.
21	None of which impacts any of the parking or
22	anything that is on site.
23	MR. KAUFMAN: All these properties
24	will still be actually useable?
25	MR. NORMANDIN: Yes.

2	MR. KAUFMAN: Has there been any
3	community opposition or anything?
4	MR. NORMANDIN: We had sent letters
5	requesting dedication for the three
6	properties. And I believe that Mama
7	Lombardi's has come back to say that they
8	were dedicated to the property. I haven't
9	heard anything on the other two.
10	THE CHAIRPERSON: Ms. Stiles.
11	MS. STILES: Particularly the
12	residential property, if it turns out that
13	they are not going to cooperatively dedicate
14	the land and condemn it, is there any way
15	that the Department could assist the
16	homeowner with any type of traffic safety
17	conscious re-vegetation, buffers?
18	I'm not sure that there are not going
19	to be preexisting houses, more roadways
20	coming closer to their home.
21	And I'm sure that there are safety
22	considerations. There are trees around the
23	corner. Is there a way that that can be
24	done? That would be helpful.
25	

1

MR. NORMANDIN: Every opportunity will

2	be taken to replace any of the existing trees
3	that could be removed where feasible.
4	Some of the buffer will be lost at that
5	residential property. But a new fence will
6	be placed back in place.
7	And where we can fit in new plantings
8	and the size and type, we would put them in.
9	MS. STILES: Thank you.
10	THE CHAIRPERSON: Please describe the
11	pedestrian facilities that you say you are
12	planning to do that are not there.
13	MR. NORMANDIN: There are no crosswalks
14	or pedestrian signals there now. And what we
15	are proposing is a connection between the new
16	sidewalk areas, the crosswalk and new
17	pedestrian signals.
Ĺ8	THE CHAIRPERSON: Would you point those
19	out?
20	MR. HEASLIP: Brian Heaslip. This is
21	the new crosswalk here.
22	THE CHAIRPERSON: So that's a crosswalk?
23	It's not an overpass? It's the pedestrian
24	overpass?
25	MR. NORMANDIN: It's just a stripe on

1	
2	the crosswalk.
3	THE CHAIRPERSON: Are there any other
4	questions?
5	(None.)
6	THE CHAIRPERSON: Can I have a motion?
7	MR. KAUFMAN: A motion unlisted neg
8	dec.
9	MR. POTENTE: Second.
10	THE CHAIRPERSON: We have a motion for
11	unlisted neg dec. Dr. Potente seconded.
12	Is there any further discussion?
13	(None.)
14	THE CHAIRPERSON: All in favor?
15	(Unanimous aye.)
16	THE CHAIRPERSON: Opposed?
17	(None.)
18	THE CHAIRPERSON: Motion carried.
19	MR. NORMANDIN: Thank you.
20	THE CHAIRPERSON: Propose reconstruction
21	of County Road 16, Horseblock Road in the
22	Town of Brookhaven.
23	MS. STILES: Mr. Chairman, I am just
24	going to recuse myself.
25	THE CHAIRPERSON: Thank you. Please

1	
2	note that Ms. Stiles will be recusing
3	herself on this particular issue. Go
4	ahead.
5	MR. MACKEY: This project, CR 16,
6	Horseblock Road, is 200 feet east in Yapank.
7	This includes repavement in selected areas.
8	So some drainage modifications will be
9	made to the existing positive drainage system
10	and some isolated leaching basins will be in
11	place to alleviate the existing localized
12	roadway flooding at certain isolated
13	locations.
14	All work will be done within the
15	existing roadway width. There is no
16	additional paved adding on in this project.
17	It's just a simple resurfacing and
18	rehabilitation job.
19	THE CHAIRPERSON: Is there any drainage
20	required at all in here?
21	MR. MACKEY: Yes. We are going to be
22	putting some isolated leaching basins where
23	there's flooding existing.
24	THE CHAIRPERSON: But flooding is not a
25	major issue on this road?

2	MR. MACKEY: In some minor areas.
3	THE CHAIRPERSON: Okay. Are there any
4	other questions?
5	(None.)
6	MR. KAUFMAN: I'll make a motion
7	unlisted neg dec. Withdrawn. I will make a
8	motion that this is a type two activity.
9	THE CHAIRPERSON: We have a motion for
10	type two. Second?
11	MR. POTENTE: Second.
12	THE CHAIRPERSON: Dr. Potente seconds.
13	All in favor?
14	(Unanimous aye.)
15	THE CHAIRPERSON: Opposed?
16	(None.)
17	THE CHAIRPERSON: Motion carried.
18	MR. MACKEY: Thank you.
19	THE CHAIRPERSON: Thank you. Proposed
20	drainage improvements on County Road 39.
21	MR. DAWSON: Good morning. Jeff Dawson.
22	I'm with the Department of Public Works.
23	This project is drainage improvements to CR
2 4	39, North Road at various locations.
25	This particular project is a phase two.

west of

1	
2	And it involves construction of a recharge
3	basin on the south side of CR 39 just west or
4	Tuckahoe Road.
5	This road was previously presented to
6	the CEQ in 1998 during which a negative
7	declaration was issued.
8	The difference in the project that is
9	being proposed to you today is that the
10	recharge basin location is across the street
11	from where it was previously presented.
12	The reason that happened is because of
13	the Shinnecock golf course that had some
14	problems with allowing us to take that land.
15	That was when the U.S. Open was in the area.
16	So this project is going to help
17	alleviate the forty accidents that have
18	happened since January 2003 at this location
19	due to the wet roadway conditions. Of those
20	40 accidents, there was one fatality with 17
21	injuries.
22	As you can see on the map, the recharge
23	basin is going to be about 1.6 acres that
24	will be planted with native species.
25	And also the area will be allowed to go

1		4.
2	back to its natural condition. Any plants	
3	that are able to be saved and replanted will	
4	be.	
5	And I guess that's about it. If you	
6	have any questions particularly on the	
7	project.	
8	THE CHAIRPERSON: Yes? Legislator	
9	Viloria-Fisher. Go ahead.	
LO	MS. VILORIA-FISHER: There has been a	
L1	great deal of talk about County Road 39 and	
12	the projects that are ahead of it to	
L3	alleviate traffic in that area.	
.4	MR. DAWSON: Right.	
.5	MS. VILORIA-FISHER: Now will this	•
_6	project be something that will have to	
-7	be done later on when the expansion is	
-8	completed? I hate to have something move	
_9	ahead and then have it redone when there is	
20	another capital project that comes along.	
21	MR. DAWSON: Right. This is within	
22	the limits of that improvement project that	
23	you are referring to. However, the only	
2.4	improvements that are going to happen within	
15	the roadway are a couple of trenches through	

2	which we can install the pipe and take the
3	water from the low side on the north side of
4	the road and run it to the south side on the
5	recharge basin. So this project will not be
6	affected by it.
7	MS. VILORIA-FISHER: I'll just watch
8	this.
9	MR. DAWSON: We appreciate it.
10	MS. VILORIA-FISHER: The second question
11	is that you have said that it will be planted
12	with native species. And I have introduced
13	legislation that I had the list of species
14	that will be on a no sell list.
15	But we also have an appendix with lists
16	of species that are on our management list.
17	We do have a member of DPW who was on the
18	evasive species task force.
19	And if you could just refer to those as
20	the planning is done with this project.
21	MR. DAWSON: Certainly.
22	MS. VILORIA-FISHER: Thank you.
23	THE CHAIRPERSON: What is the rainfall
24	that you designed this for?
25	MR. DAWSON: I believe that's on the

1	
2	map. If you can just let me take a look
3	on the map. It's a 4.3 inch rainfall event.
4	And that's equivalent to a five year design
5	storm.
6	THE CHAIRPERSON: Now it's hard to
7	believe, you said 1998 you reviewed this
8	originally. How would you compare the
9	effectiveness of this alternative to the
10	original plan? Are we losing much?
11	MR. DAWSON: No, we are not losing
12	anything at all actually. The original
13	difference is that had the recharge basin
14	been located to the north side of the road on
15	the Shinnecock Hills golf course property, it
16	would have required less piping as well as
17	the roadway intersection is super elevated.
18	Meaning that the south side of the road is
19	higher than the north side.
20	So it would have been easier
21	hydraulically to get the water to remain on
22	the north side which is the natural low
23	point.
24	But the only difference is just an
25	addition of pipes. It's going to allow us to

1	
2	take the water from the low point on the
3	north side and convey it to the south side.
4	THE CHAIRPERSON: Whose property are you
5	conveying it?
6	MR. DAWSON: This is actually the
.7	Nature Conservancy property. We have been
8	coordinating with them about this parcel.
9	We are actually in a lease agreement
10	right now where phase one of this project is
11	currently being constructed due to the
12	severity of the traffic accidents at this
13	location.
14	They agreed to allow us to use about a
15	fifth of that parcel, the 1.6 acres right
16	now. And that's in construction.
17	This phase two is going to widen the
18	recharge basin and allow for the full volume
19	that is required.
20	THE CHAIRPERSON: And you have a formal
21	agreement with the Nature Conservancy?
22	MR. DAWSON: We are in a lease
23	agreement. I'm not sure of the dates of
24	that agreement. But I know that it's
25	temporary until the acquisition of this

1	
2	parcel is executed.
3	THE CHAIRPERSON: So you are going to
4	actually purchase this property from the
5	Nature Conservancy?
6	MR. DAWSON: Yes.
7	THE CHAIRPERSON: Okay. Yes?
8	MR. STILES: Do you know how the Nature
9	Conservancy came onto this property? Was it
10	a deletion?
11	MR. DAWSON: A good question. I don't
12	know the answer to that.
13	MR. POTENTE: Do you know the name of
14	the preserve?
15	MR. DAWSON: No, I do not.
16	MR. POTENTE: Is this the entire
17	portion of the preserve?
18	MR. DAWSON: This is actually a
19	triangular piece of property. The entire
20	parcel is triangular. This section of the
21	parcel is a wedge shape between CR 39 and the
22	railroad tracks.
23	So we are talking of the Nature
24	Conservancy and they agreed that this portion
25	of the parcel wasn't completely

1	
2	environmentally sensitive.
3	As well as when we do take the land,
4	the Nature Conservancy is going to be able to
5	have funding to buy more sensitive land.
6	This corner of it was a small chunk of the
7	big parcel.
8	THE CHAIRPERSON: Yes?
9	MS. STILES: Is there any conditions
10	in the agreement that you are going to have
11	with the Nature Conservancy that those monies
12	will be used in the same general location for
13	replacement?
14	MR. DAWSON: I'm not sure of the actual
15	agreement as it stands now. But we did speak
16	with the Nature Conservancy.
17	And they did indicate that they are
18	going to acquire additional land with the
19	money that they get. I'm not sure exactly
20	where though.
21	THE CHAIRPERSON: Motion?
22	MR. KAUFMAN: This is an acquisition.
23	I'll make a motion unlisted neg dec.
24	THE CHAIRPERSON: Motion unlisted neg
25	dec. Second?

1 .	
2	MR. POTENTE: Second.
3	THE CHAIRPERSON: Seconded by
4	Dr. Potente. All in favor?
5	(Unanimous aye.)
6	THE CHAIRPERSON: Opposed?
7	(None.)
8	THE CHAIRPERSON: Motion carried.
9	Thank you.
10	MR. DAWSON: Thank you.
11	THE CHAIRPERSON: All right. So let's
12	go back to the Airport. The proposed
13	redevelopment of Long Island Jet Center East,
14	Francis Gabreski Airport in the Town of
15	Southampton. Anybody here like to speak for
16	that?
17	MR. CEGLIO: Good morning. Tony Ceglio,
18	Airport Management Rescue Corps.
19	MS. STILES: I'm going to recuse myself
20	on this.
21	THE CHAIRPERSON: Note that Ms. Stiles
22	is recusing herself on this issue.
23	MR. CEGLIO: I just want to make a
24	note before I start that there are
25	representatives from the Louis K. McLean

Associates and the Long Island Jet Center here to review the specifics of the project after I go through a complete review.

I'd like to start out by saying that historically the Gabreski Airport property was developed on approximately 1,500 acres in 1943 as the Suffolk County Air Force base.

It was operated on and off by the Air
Force until being turned over to Suffolk
County by the federal government in 1972
through the Surplus Property Act of 1944 and
a quick claim deed.

A quick claim deed requires, among other things, that the County operate the facility as an airport for the benefit of the public.

The airport has to stay open 24 hours a day, seven days a week.

The County must also provide land to tenants who are willing to construct facilities to service aircraft on a fair and equitable basis.

The requirements of the quick claim deed are also echoed in assurances and grants received from the federal government.

1

2	Presently Gabreski Airport is situated
3	on approximately 1,452 acres in West Hampton
4	Beach in the Town of Southampton.
5	Long Island Jet Center is one of two
6	fixed base operators at Gabreski Airport.
7	AFO is a company that services the airport.
8	They provide aircraft fuel, parking and
9	other services that are required for aircraf
10	using the airport.
11	Long Island Jet Center services about
12	60 percent of the jet aircraft that come
13	into the airport based on fuel services
14	collected.
15	Their clientele consists mainly of
16	corporate and private general aviation
17	aircraft. Their existing aircraft space is
18	inadequate in peak summer months.
19	In order to accommodate the aircraft
20	that use their services during the busiest
21	months, they need to request the use of
22	remote areas at the airport for the parking,
23	requiring the airplane to be towed across
24	taxiways and runways. Their intent is to
25	and ranways. Their intent is to

construct three 15,000 square foot hangers

1	
2	for corporate aircraft and seven hangers for
3	small aircraft and additional outdoor areas
4	for ramp parking.
5	They also include to relocate their
6	current fuel and fuel capacities to meet the
7	current and future demand for services at the
8	airport.
9	In the environmental assessment form
10	it's also indicated that they will remove an
11	underground storage tank that was previously
12	used for heating oil prior to being converted
13	to natural gas heat.
14	Their proposal will provide ample
15	parking for the current aircraft using the
16	airport. The large hangers could also be
17	used to house aircraft on a year round basis
18	and creating jobs and night crews and service
19	personnel.
20	The project is consistent with the 1990
21	master plan for the proposed site and is
22	consistent with the Pine Barrens
23	Comprehensive Land Uses Plan regarding
24	clearance standards.

The EAF or Long Island Jetways reviewed

2	by the Council of Environmental Quality in
3	August of 2005 resulted in a recommendation
4	for an unlisted action with no significant
5	adverse impact to the environment.
6	The recommendation was reviewed by the
7	legislature on March 14, 2006. The
8	legislature asked CEQ to reevaluate the EAF
9	which is where we are here today.
10	As a result, the EAF form was revised by
L1	the Department of Planning and the Department
L2	of Economic Development Work for Housing to
L3	include additional information about projects
L4	at the airport and specifically the Long
L5	Island Jet Center.
L6	I'd like to point out that the
17	information submitted to you is a report from
.8	the Airport Conservation Assessment Panel or
19	ACAP.
20	ACAP was created by County executive
21	order to review proposed leases at the
22	airport and to submit their recommendations
23	to CEQ and the legislature.
4	There is one change to the EAF form that
	has been submitted to you. A small area

1	
2	contained in the proposed lower area contains
3	County owned buildings housing electrical
4	equipment for airport runway and taxi
5	lighting systems.
6	It will remain County owned property
7	and have to be removed from the legal mets
8	and bounds description.
9	I have a handout. Actually somebody
10	from McLain Associates will hand that out to
11	you.
12	I think it's three pages that have
13	changes, minor changes in it. The revision
14	basically decreases the overall property by
15	0.09 acres. The total proposed lease area
16	will be just under 10 acres or 8.98.
17	As I mentioned, McLain Associates is
18	here on behalf of Long Island Jet Center to
19	review the project in more detail with you.
20	With your permission I'd like to ask them to
21	make that review.
22	MR. SPEISER: My name is Andrew Speiser
23	from McLain. Good morning, ladies and
24	gentlemen. Thank you very much.
25	I'd like to draw your attention to

1	
2	begin with to some of the displays that we
3	have here. You may be very familiar with the
4	site. In case you aren't, these aerials will
5	help to identify what is going on.
6	Good morning. Just to draw your
7	attention to the displays that we have here.
8	Hopefully you can see them from where you are
9	seated.
10	First off generally Gabreski Airport is
11	identified by the boundaries on this aerial
12	photograph. As we can see from this,
13	Gabreski Airport is surrounded by some
14	dedicated open space.
15	We have some central pine barrens, corps
16	preservation area of the pine barrens to the
17	north.
18	There are some corps preservation areas
19	to the east along with Quogue Wildlife
20	Refuge. There is still development that's
21	over on the west side with additional open
22	space there and an area of development to the
23	south.
24	Within Gabreski Airport itself there is
25	

some corps preservation area of the pine

1	
2	barrens located along the east side.
3	There are also some areas of the
4	compatible growth area which the rest of the
5	airport is dedicated for which will not be
6	touched with any vegetative clearing.
7	Long Island Jet Center is located
8	internal to the airport and is not adjacent
9	to any of these detected areas. It's not
10	adjacent to the corps areas.
11	It's not adjacent to any of the
12	compatible growth areas of which there will
13	be the prevention of any clearing. It is
14	substantially located internal.
15	It is a project which is a stand alone
16	project. It's not connected with any other
17	action that's happening. And as such it's
18	not adjacent to any open space areas.
19	This diagram is a close up aerial of the
20	action for Long Island Jet that you had seen
21	in the smaller scale. That area bordered in
22	orange is Long Island Jet's property.
23	Currently they are using a portion of
24	the property from this line in front of the
25	cars, believe it or not if you can see it on

1	
2	there, just north of these airplanes.
3	They currently use this area all to the
4	south. Airplanes are parked on the apron.
5	Airplanes are parked on the grass areas here.
6	And this is due to the amount of needs that
7	they have for servicing aircraft which
8	currently come to the airport.
9	Through this lease that they will be
10	obtaining, the area to the north here would
11	be added to the property that they would be
12	using.
13	The total leased area is 9.90 acres.
14	The area that they are currently using is
15	5.04 acres which means that the remainder of
16	the area that they will be taking is going to
17	be 4.94 acres.
18	The electrical vault and emergency
19	generator that was alluded to before is this
20	area up here where these buildings are
21	located.
22	I'd like to point out that with the
23	exception of just over half an acre of wooded

ded area, the remainder of the site has all been completely disturbed.

2 This area has been cleared. It's been 3 graded. It's shown on the Suffolk County Highway Survey as being cut and fill land. 5 There were previously some structures 6 and buildings located in the north of the 7 current administrative building which has 8 been demolished. 9 There were also some other structures 10 that were located in this area where there 11 was parking as well as a taxiway which is 12 currently located going through the area 13 which Long Island Jet uses as well as into 14 the area which would be given to them for 15 their overall lease. 16 So the whole site itself is 17 predominantly disturbed. This is not a 18 virgin area. This is an area which has been 19 experiencing air traffic for a long time. 20 This is not a new business in a new 21 airport. This is an existing aircraft 22 service company at an existing ongoing 23 airport. Long Island Jet operations are 24 shown here on this site plan.

THE CHAIRPERSON: We have a question.

2	MS. VILORIA-FISHER: Before you go
3	on. I want to be clear about something on
4	this here.
5	MR. SPEISER: Sure.
6	MS. VILORIA-FISHER: The legend that
7	is closest to the pine barrens area, the
8	legend refers to the crosshatched area
9	as areas cleared or to be cleared.
10	I just want to verify with you that that

2	MR. SPEISER: You're pointing to an
3	area up here.
4	MS. VILORIA-FISHER: It has nothing
5	to do with your project?
6	MR. SPEISER: None whatsoever. This
7	project is strictly isolated to the small

9	MR. FULKERSON: Roy Fulkerson. The
10	32 acres shown in yellow is the area where
11	Long Island Jet Center is. And that's the
12	only part.
13	MS. VILORIA-FISHER: That's the only
14	part that we are concerned with today.
15	MR. FULKERSON: Yes.
16	MS. VILORIA-FISHER: I'm asking because
17	there has been a great deal of discussion
18	regarding any impact on the pine barrens.
19	MR. FULKERSON: Right.
20	MS. VILORIA-FISHER: I just want to put
21	on the record that that crosshatch was not
22	involved.
23	MR. BAGG: If I may point out. That
24	information was submitted as part of the
25	EAF. That area has been cleared.

It was presented to the Pine Barrens 2 3 Commission. The green areas were improved as being in compliance with this clearance 4 5 standard of keeping 35 percent of the airport 6 in its natural state. 7 The airport has much more than 35 8 percent of its natural state. Currently it 9 has about 70 to 73 percent in its natural 10 state to meet the pine barrens. 11 But that map was presented to show that 12 the pine barrens had reviewed clearance at 13 the entire airport site and it's in 14 conformance. 15 MS. VILORIA-FISHER: Thank you, Jim. 16 MR. SPEISER: But you can see over here 17 on the site plan diagram is where different 18 buildings are intended to be placed within 19 this proposed leased area. 20 Now let me just get back to one other 21 point here. This project is substantially 22 similar to what was presented before the 23 CEQ back in 2005. 24 The difference being that the leased 25 area has been moved somewhat north and now

25	have been much more conservative in looking

2	to at least three or four inches of rain.
3	Okay.
4	MR. SPEISER: The project is not
5	going to change the use of deicing chemicals
6	that had been used. They have been using
7	propylene glycol in the past.
8	The facility uses a very small amount.
9	They currently have about 1,850 gallons in
10	a spray truck. They do not store all the
11	storage of propylene glycol.
12	This is a new solution of propylene
13	glycol that is used for deicing purposes.
14	And although the tank holds 850 gallons,
15	over the years they have used half that on
16	an annual basis.
17	Propylene glycol is not a hazardous
18	material. It is not on the New York State
19	list of hazardous substances.
20	MR. KAUFMAN: I know that that chemical
21	is actually a glue component.
22	MR. SPEISER: That is correct. It's
23	generally usable in food substances.
24	MR. KAUFMAN: His question is, is there
25	any kind of recovery for that? I know at

2	larger airports where they have much greater
3	volumes for this stuff, they have recovery
4	steps and they keep pumping the same solution
5	in here. I didn't notice any kind of
6	recovery system in here.
7	MR. SPEISER: There was no recovery
8	system based on the small amounts. And
9	in this case the Agency for Toxic Substances
10	and Disease Registry identifies that this
11	material breaks down in the environment
12	within several days to a week.
13	MR. KAUFMAN: Has the Suffolk County
14	Department of Health communicated anything
15	to you about possibly recovery of this
16	chemical?

7	you are correct in what you just said as to
8	planes not staying there overnight,
9	particularly the jets.
10	They farm out to Teterboro and Republic
11	I even heard of them going up to Stewart.
12	So there is a possibility in what you
13	are saying that there will be basically a
14	50 percent reduction in particular types
15	of aircraft. Basically they fly in. They
16	stay.
17	And then they fly out a couple of days
18	later rather than going in, leaving, coming
19	back. So there is a potential for lesser
20	air traffic in a certain way.
21	Okay, nonetheless though this is a
22	present level of capacity at the airport
23	right now in terms of these facilities by
24	the FBO.
25	

That present level of capacity is

2	apparently inadequate from the documents that
3	I have been seeing and again from my own
4	personal knowledge of this.
5	What is going to be the capacity level
6	once this is built? Will it be enough just
7	to handle what is needed there right now? Or
8	will there be quite a lot of capacity?
9	But you will not necessarily have people
10	coming in. I mean, how much capacity
11	basically are you over building if you will?
12	Or is there any over building going on?
13	MR. MCSHANE: Bill McShane, Long Island
14	Jet Center. We don't believe that this
15	development meets the demand that is at the
16	airport.
17	Long Island Jet Center put in a proposal
18	for the airport in 1997 for the development.
19	We are as it were behind the power curve in
20	terms of supporting industry's needs.
21	What it does is that it allows us to
22	operate more safely and move these airplanes
23	around on the airport.
24	So the capacity at the airport will
25	continue to be handled this year and next

year.

However, in terms of taxis they will be parking airplanes on runways, we routinely close the taxiway on summer weekends, with the permission of the airport many times and the control tower in the safest possible way.

However, every time you hook up to an airplane you risk damaging that airplane and causing a problem.

So it provides for a safer way to operate. It doesn't change the capacity capabilities of the airport per se.

MR. KAUFMAN: You will not become a magnet if you will for increased traffic?

MR. MCSHANE: I think that what we were able to show in 1997 and forward was that the provision of additional services at an airport improves the compulsion relationship which reduces the number of flights that leave an airport like this which is a regional airport and seasonal airport.

And it provides for increased economic benefit. We had less takeoffs and landings, more fuel volume and better revenues for the

2	County as a result of us arriving at the
3	airfield and providing those services.
4	This will I think have the same impact.
5	Any growth at the airport that will come as a
6	result of the development of the east end
7	will come regardless.
8	As I said once before, I think at a
9	meeting we can only prepare for the growth
10	that comes to our region. We cannot create
11	it.
12	Gabreski Airport has had a 9,000 foot
13	runway there since, when was the airport
14	formed? 1943.
15	Clearly the demand isn't there for
16	regular air carrier service nor do we wish to
17	have it on the east end of Long Island. And
18	we do not propose to support that type of
19	development.
20	We are just trying to meet the demand at
21	the airport today and provide a safer service
22	for our customers. That's about it.
23	THE CHAIRPERSON: Legislator Viloria-
24	Fisher.
25	MS, VILORIA-FISHER: We didn't discuss

2	noise abatement and that condition before the
3	legislature by the neighbors.
4	As I look here, I looked at the program
5	called Fly Neighborly, the recommended
6	procedures for pilots. How does that work?
7	Is it a voluntary procedure that you
8	recommend that pilots use? So that they will
9	be lowering the noise levels of arrivals and
10	takeoffs?
11	MR. CEGLIO: If you don't mind, I'll
12	do it. That's Tony Ceglio. The Airport
13	Noise and Capacity Act of 1990 will not allow
14	us to force noise abatement on pilots.
15	As such with the help of the community
16	we developed a voluntary noise abatement
17	program to try to help reduce the noise
18	generated in the communities surrounding the
19	airport. It's voluntary.
20	We have tried to get the people that are
21	based at the airport to follow it. And also
22	if people don't follow it, we sent out
23	letters to try to get them to comply with
24	these voluntary procedures.
25	It's not the silver bullet. It doesn't

2	help immensely but we have made progress in
3	the last year.
4	And I think that we helped reduce some
5	of the noise in those residential communities
6	surrounding the airport.
7	MS. VILORIA-FISHER: I also read before
8	I read about the flight neighboring program a
9	number of recommendations to the Town, to the
10	municipality regarding what kind of building
11	they were permit around the airport and that
12	noise soundproof material be used. How
13	receptive has the Town been to these
14	recommendations?
15	MR. CEGLIO: I am not really sure of
16	that. I have recommended to them, the
17	development that is proposed just south of
18	the airport that they imply or comply with
19	some of the recommendations that the FAA has
20	out there for soundproofing.
21	And generally what it includes is sound
22	insulation in the roof, better doors, triple
23	insulated windows, that sort of thing. I
24	don't know if they have adopted any of that.
25	MR. BAGG: Yes, I believe that the

Planning Commission, those things that are in
the packets are the standard recommended by
the Suffolk County Planning Commission.

First and foremost they didn't recommend
any kind of residential development in the

past for the runways.

And if the towns are going to approve subdivisions that the homes should be noise proof. But I did not believe that the Town proceeded with any of those recommended standards and noise proofing structures.

MS. VILORIA-FISHER: Thank you.

THE CHAIRPERSON: I have a statement that I would like to get you to react to.

This comes from the December 15th meeting of the Airport Conservation Assessment page.

And their first environmental assessment notes, they say that the application, assuming that your application failed to disclose that this project sits within the Town of Southampton aquifer protection overlay district, the Suffolk County Pine Barrens and the Suffolk County sole source aquifer. What is your reaction to that?

2	MR. SPEISER: The project does exist
3	within those areas. But it will be in
4	compliance with what is going on.
5	Basically all of Long Island is a
6	federal sole source aquifer. Not basically.
7	It is.
8	Every bit of development, everything
9	that happens on Long Island is within that
10	location. The intent of the development here
11	is going to be in keeping with the ground
12	water.
13	In compliance with Article 12 of these
14	tanks it will be in compliance with what is
15	going to be necessary to protecting ground
16	water to the federal source as well as a
17	district.
18	THE CHAIRPERSON: So your proposals
19	in no way violate those protections?
20	MR. SPEISER: It will help to protect
21	the ground water and therefore it is in
22	compliance with those zones.
23	THE CHAIRPERSON: Well I'm not sure by
24	adding jet fuel or anything that it's going
25	to help the adulter no matter what Dut at

1	
2	least it's not going to make it worse. Is
3	that right?
4	MR. SPEISER: It won't make it worse.
5	And the regulations that are in place, the
6	requirements for what will be with these
7	tanks will have to go in, will be the current
8	state of the art protection for them.
9	THE CHAIRPERSON: Go ahead.
10	MR. KAUFMAN: Regarding the aquifer
11	protection district, I do know that
12	Southampton recently, I think it was in 1999,
13	went through a comprehensive plan update.
14	And if I'm not mistaken, reading from
15	documents that were submitted to us, I have
16	an independent knowledge of it, calls for
17	continued use and development of Gabreski
18	Airport for industrial and recreational
19	purposes.
20	And therefore any activities have to
21	be in compliance with the aquifer protection
22	overlay district. And that's one thing.
23	That's at the Town level.
24	To the extent that this is County owned
25	property and to the extent that the County
	-

regulations supersede to some degree the Town
of Southampton regulations, are you going to
be trying, there is a legal split if you will
between the two.

Are you going to be trying to meet both
of them in terms of trying to protect the
aquifers?

MR. SPEISER: What is going to be put in place indeed would be protection. We feel that the current upgrade of tanks that are there would offer an additional level of protection from what would be currently going on and be what is inappropriate with the current regulations. And therefore it would be applicable to both.

MR. KAUFMAN: Thank you.

THE CHAIRPERSON: Another point that was brought up. With the increase size of the fuel storage that is there, it would allow full deliveries of fuel to be made.

Currently the operation is such that they have to have multiple deliveries come on a weekend to handle the traffic currently coming to the airport.

2	And so the fuel trucks stack up. There
3	is additional deliveries that are necessary
4	which just results in more opportunity for
5	spillage if it were to be allowed to occur.
6	By allowing the fuel storage proposed,
7	we hope to be able to get full fuel
8	deliveries required on a summer weekend.
9	THE CHAIRPERSON: Thank you.
10	MR. FULKERSON: Another point regarding
11	fuel is that according to the 1990 airport
12	master plan the fuel storage at Gabreski was
13	231,500 gallons.
14	It was reduced from 231,500 gallons to
15	36 gallons in 2006.
16	If this project goes forward, it will be
17	a total of 42,000 gallons stored which is
18	still 21 percent of the amount that was
19	stored at one point back in 1990 or which was
20	shown in the master plan in 1990.
21	THE CHAIRPERSON: Thank you very much.
22	You will be in the audience I presume if
23	we have further questions.
24	MR. SPEISER: Yes.
25	THE CHAIRPERSON: At this time I'd like

1	
2	to get comments from the public. And the
3	first person I have on the list to speak is
4	Jamie Siegel. And we'll give you three
5	minutes.
6	MR. SIEGEL: Jamie Siegel. I am a

10	I wanted to talk about the overview of
11	the Committee and how we came to the findings
12	this morning, the three community members,
13	one member of the legislature, a member of
14	the County executive staff, a member of the
15	airport community and a member of the
16	business community.
17	We basically came to the realization
18	after the meeting that generated a 51 acre
19	airport with the backdrop and findings that

And I don't know if you have the full report but I have copies for you guys just in case. I know that you have the actual text but I don't know if you have the supporting documentation.

we submitted to you guys.

2 The Committee was created by the 3 Executive Board in 2006. And essentially on December 15th we did meet and we reviewed the application, the EAF that was put in front of 5 6 us. Our findings basically on the 8 environmental came up that we were going to 9 ask for a type one action from CEQ. 10 We were hoping that we were going to get 11 a type one action. In the future we are 12 going to be coming before you again. 13 This was a very tough deliberation for 14 We are going to come forward supporting 15 other actions that are not going to be type 16 one that will be neg decs for other things 17 that we look forward down the pike of things 18 that are coming before us. But this one we 19 thought was a type one action. 20 We tried to be reasonable, thoughtful, 21 and it was a very tough decision. But we 22 came up with a type one on this one. 23 Bob DeLuca who was an ex officio member 24 of the Committee is going to be speaking

about some of the environmental findings

1	
2	because he can explain them a lot better than
3	I can. But I'm just going to go over some of
4	the lines for you.
5	We thought that or they did speak just
6	before us, the gentleman spoke about it and
7	it was an excellent question about the fuel
8	storage capacity.
9	I just wanted to point out that the 1990
10	master plan number was, that fuel storage was
11	not independently owned.
12	It was owned by Suffolk County. It was
13	the previous tanks that were Air National
14	Guard tanks.
15	That was in use for public sale by a
16	vendor AFBI at Gabreski.
17 18	So when they said the numbers are being
19	reduced to a percentage of that, that is not
20	really a true percentage. The numbers are
21	actually going to be increased but the work
22	plan says that they are going to be increased
23	by 24,000 gallons. And really the 231,000
24	gallons were never available for public uses.
15	Furthermore, they say that one of the
Ü	alternatives on the EAF is to do nothing. If

2	they do nothing
3	THE CHAIRPERSON: Would you please
4	summarize.
5	MR. SIEGEL: Yes. Basically we are
6	asking for a type one action. And I'm sure
7	you've read the report and I appreciate it.
8	And I believe that Bob DeLuca, I'll
9	leave him to go forward now with the
10	summaries on the environmental findings if
11	you would allow him.
12	THE CHAIRPERSON: Thank you very much.
13 .	MR. SIEGEL: Thank you. I'd like to
14	just give this to you.
15	THE CHAIRPERSON: Fine. The next
16	person on the list is Robert DeLuca. We'll
17	take a five-minute recess.
18	(Recess.)
19	(After recess continuing.)
20	THE CHAIRPERSON: All right, our
21	reporter is back. If we can reconvene, I'd
22	appreciate it. All right, Bob.
23	MR. DELUCA: Good morning. My name
24	is Bob DeLuca. I also serve as an ex
25	officio member to the ACAP panel.

2	And in that role I have been asked to
3	provide some environmental expertise and
4	advice to the panel which some of you may
5	remember years ago I used to get to you on
6	behalf of the County Health Department.
7	Basically I have three points that I
8	would like to make regarding largely the
9	procedure.
10	And the procedure relates to the
11	decision as to whether or not this is a type
12	one or an unlisted action. I wanted to give
13	you the benefit of my thinking on this as
14	part of your deliberations.
15	The first issue which came before us
16	was the size of the project and when it was
17	presented to us the overall size of the
18	project was just over ten acres and .05.
19	As you know now, there has been a
20	modification to that which takes the project
21	size to 9.98 acres.
22	And 617.4B6 of the rules and regulations
23	governing SEQRA sets a threshold for a type
24	one action. Just over ten acres.
25	We had a type one action. Now we are

2	9.91 acres. So I would ask you to consider
3	that as to whether we want to round up or
4	round down when it comes to environmental
5	review.
6	The second matter relates to expansion
7	review. This also falls under Part 617.4B6
8	and relates to the expansion of existing non-
9	residential facilities by more than 50
10	percent of the ten acre threshold.
11	So in addition 50 percent of the ten
12	acre threshold be about five acres. And it's
13	been a bit of a moving target.
14	But as best I can tell, the overall
15	activity based on the project is somewhere
16	around 5.8 acres.
17	I would argue that the 5.8 acres meets
18	the 50 percent of the ten acre threshold.
19	And so that was the basis for a type one
20	classification.
21	Finally 617.4B.10, this portion of SEQRA
22	regs relates to the parkland issue.
23	And this would be any unlisted action
24	that exceeds five percent of any of the
25	thresholds in this section, referring to the

1	
2	above sections, the 50 percent of ten acres
3	or the ten acres.
4	And in that case if you have 2.5 acres
5	that occurs wholly or partially within or
6	substantially continuous 2.2, any publicly
7	owned and operated parkland, recreation area
8	or designated open space, you have a type one
9	action.
10	We would argue that although the
11	applicant has pointed out his view or their
12	view that it's a stand alone project, I would
13	make the comparison that that wholly owned
14	cheese cake is a stand alone project.
15	It is by no means a stand alone project.
16	It is functionally dependent on the overall
17	airport facility.
18	And the reason that's of some interest
19	is because in making a determination, you are
20	asked to look at things like growth, noise,
21	traffic, air traffic or car traffic.
22	And these two items are definitely
23	related. So the fact that the Quogue
24	wildlife refuse may be several hundred feet
25	across the tarmac from the fixed base

1	
2	operator and that the corps of the pine
3	barrens may be a thousand feet to the north,
4	I would simply ask that you consider this as
5	you would any other SEQRA project where you
6	are asked to look at the overall action.
7	This is an airport use on an airport.
8	Again I don't know the answer to this
9	question. But it may potentially induce
10	growth with the over fixed base operator.
11	THE CHAIRPERSON: Would you summarize.
12	MR. DELUCA: And I think that you are
13	responsible as to certainly take the broadest
14	views that you can. I think that there is a
15	good argument for a type one designation.
16	Even if it is not a type one designation
17	as you know, SEQRA asks that you take a full
18	look at the impact. It's simply lowers the
19	threshold when it is a type one action.
20	A cap was created to increase
21	transparency, scrutiny and public input in
22	the process. And hopefully that is what we
23	have been able to do with the information.
24	I thank you very much for your time.
25	I would be very happy to answer any questions

1	
2	that you may have before I step down.
3	THE CHAIRPERSON: Ms. Viloria-Fisher.
4	MS. VILORIA-FISHER: Thank you. Good
5	morning. I just have a question about the
6	increased air traffic. Promoting air
7	traffic.
8	MR. DELUCA: Good morning.
9	MS. VILORIA-FISHER: The presenters
10	indicated that indeed what would result would
11	actually be or would reduce air traffic
12	inasmuch as they said that the aircraft would
13	be able to remain I guess overnight. And so
14	that there would be a reduction. What is
15	your response to that?
16	MR. DELUCA: I guess my opinion would
17	be that I don't know enough about air
18	transportation to answer that question
19	specifically.
20	This process would allow you to get
21	those details. There is a bunch of people
22	that live in the neighborhood that might feel
23	otherwise.
24	So this is one of those areas where
25	people, and I have been in this business a

1	
2	long time, people regularly say something.
3	It may turn out to be true. That's fine.
4	The environmental impact statement
5	process gives you the opportunity to lay it
6	out so that everybody can see what the basis
7	for that is. Maybe we can find out more
8	information that way.
9	MS. VILORIA-FISHER: Thank you.
10	MR. POTENTE: Are there any living
11	concerns with this project?
12	MR. DELUCA: Again I try to take my
13	role here as a reviewer from the procedural
14	side. But on the substantive side my
15	greatest concern is growth.
16	From what we saw at ACAP, I think that
17	there is enough information to show you in
18	your folder as well.
19	This is in a sense a kind of private
20	terminal. It's not simply just making it a
21	little bit better.
22	It's a very nice facility that's going
23	to provide a lot of amenities. And there is
24	a potential for that I think to draw more
2 =	

aircraft.

24

25

2 Now there is another fixed base operator 3 and we don't want to compete with this or risk that business not doing so well. 5 So I think that those are the kind of 6 issues that lie at the heart of this. And ultimately the greatest concern here is that 8 we try to maintain the airport in a level and 9 manner that we don't allow something in there 10 that might cause growth inducement that we 11 haven't prepared for. 12 THE CHAIRPERSON: Mr. Kaufman. 13 MR. KAUFMAN: I noted in several of the 14 documents that were presented to us including 15 the ACAP document that the issue of some of 16 the plans being outdated was raised. 17 Is that a policy decision? Or is that 18 something that you simply feel exists? 19 How do I relate that to SEORA? 20 MR. DELUCA: Well I guess I would look 21 at it this way. Since the 1990 mandate, 22 at the airport, the legislation has come into 23 place. And it's put in a number of

I don't know that one automatically

restrictions at the airport.

2	trumps the other. If Suffolk County wants
3	there to be a new master plan, there is a
4	state wide law that oversees the entire
5	facility. All of that suggests that the
6	value of the plan is diminished over time.
7	MR. KAUFMAN: But you also have a
8	problem with what you just said. In that
9	pine barrens plan the airport is compatible
10	growth area.
11	Essentially it's a TDR zone. How does
12	that outdate the 1990 master plan?
13	MR. DELUCA: Well I'm not even arguing
14	that this application shouldn't go through.
15	I'm arguing how it should be reviewed.
16	So I am perfectly comfortable with the
17	fact that there is a compatible growth area.
18	What I am least comfortable with is that we
19	not review with the greatest level scrutiny
20	the activity that goes on there.
21	MR. KAUFMAN: You do make a point of
22	environmental question. How do we review
23	it under the standards of SEQRA as opposed to
24	policy and whether this kind of an issue,
25	whether this kind of growth if you will is

2	something that is permitted in the area?
3	That's a policy decision.
4	MR. DELUCA: Growth inducement is
5	clearly something identified in the
6	regulations that a lead agency has an
7	obligation to take a look at irrespective of
8	any airport policy or pine barrens.
9	MR. KAUFMAN: We have a 1990 plan out
10	there saying that this is an airport and
11	it shall have some growth to it in its
12	use as an airport.
13	Also we have a TDR program essentially
14	pointing pine barrens credit toward this
15	area.
16	We have light industrial zoning by the
17	Town of Southampton which essentially points
L8	development toward this area. We don't have
L9	restrictions in there preventing certain
20	developments from occurring.
21	I just don't, even if growth is an issue
22	to look at, I don't see how, I'm trying to
23	phrase the question and I'm not sure if I'm
24	phrasing it correctly.
_	

When we've got a number of programs out

2	there, I'm pointing towards development in
3	this area. Obviously we have to look at it
4	in terms of SEQRA.
5	But outdated doesn't tell me anything.
6	It doesn't help me make a decision under
7	SEQRA.
8	Yes, I understand that growth is out
9	there. But making just a bald face statement
10	that this is outdated, that's a policy
11	decision each time.
12	It's a judgmental decision as opposed to
13	showing me an actual environmental effect.
14	MR. DELUCA: Sure. You and I could
15	well differ on what the outdatedness of that
16	report would be.
17	I would just say this. I don't think
18	that you need the outdated airport master
19	plan to beg the question as to what the
20	potential growth inducement might be, whether
21	the airport master plan was current or not.
22	I'm just saying that it adds to the
23	weight of evidence that would cause me to
24	say maybe we should take a closer look.
25	And just for example the Town of

2	Southampton and the County Executive have
3	often said that that desire for growth is to
4	argue aviation. If we get some industrial
5	roads here, maybe we'll get less planes.
6	MR. KAUFMAN: I'm not sure that you can
7	go that far really. I've heard the statement
8	and I can't make a determination.
9	THE CHAIRPERSON: Mr. Bagg.
10	MR. BAGG: I think it should be pointed
11	out that when you talk about 1990 airport
12	master plan, then you have the STPA plan
13	passed in 1992 which calls for future
14	development and further development at the
15	airport to concentrate development there
16	rather than elsewhere in the area for
17	recharge.
18	And you've got the 1995 pine barrens
19	plan or three pine barrens plans which says
20	that the airport should be a receiving area,
21	that it should concentrate development.
22	It should take those areas or pressure
23	off those other areas in the pine barrens
24	from being developed which normally would.
25	You have a 1990 master plan update
	~ +

2	from the Town of Southampton that clearly
3	states that the airport should be developed
4	for both aviation as well as industrial
5	purposes.
6	So those plans are ineffective on the
7	books. And they all either support future
8	growth at the airport and I would assume that
9	those plans are cumulative growth, future
10	growth in that particular area as opposed to
11	elsewhere in the town in the pine barrens.
12	MR. DELUCA: Well let me respond this
13	way. Every piece of property in Southampton
14	town has a zoning which describes, that it's
15	going to be residential or industrially
16	zoned.
17	And every comprehensive plan has gone
18	along with that. That doesn't mean that we
19	stop doing the SEQRA process.
20	We take a look very carefully when those
21	projects, when they come in to discern
22	whether the project is environmentally
23	harmful.
24	That's the test. Not that we know it's
25	an industrial area. Whether or not we have

2	carefully scrutinized and reviewed the
3	transparent. So that everybody knows what
4	the deal was when it got approved.
5	MR. KAUFMAN: What you are basically
6	saying is that when a project is proposed
7	that it's compatible with the zoning in the
8	area, then it's a neg dec. If the zoning
9	allows it and if it conforms with the basic
10	concept for control of that area.
11	MR. DELUCA: I don't think I said that.
12	MR. KAUFMAN: That's what I'm saying.
13	MR. DELUCA: I said basically the
14	zoning category does not do the SEQRA
15	process.
16	MR. KAUFMAN: I am not saying not to do
17	the SEQRA process. But basically a decision
18	under SEQRA when you say light industrially
19	zoned and an LI zoned application comes in
20	and if it's not going to cause any particular
21	significant impact or something like that,
22	presumptively it's a neg dec.
23	You have to look at it though and see if
24	the issue has not been considered or if it's
25	outside of what normally would be a neg dec,

1	
2	then it might not fly.
3	But if it does conform with what you've
4	got on the books and if it's in conformance
5	in every way, shape and form, then you really
6	got no choice. You have to delay a neg dec
7	on that situation.
8	MR. DELUCA: Sure. And I think that's
9	the rule of the law. I think in the aquifer
10	protection overlay district, the storage of
11	hazardous materials is presumptively
12	incompatible.
13	This project proposes, and I'm not
14	saying that this is illegal or shouldn't
15	happen but it proposes to actually increase
16	the amount of a presumptively incompatible
17	use.
18	MR. KAUFMAN: Obviously we have to think
19	about it. But as you were just saying, that
20	particular overlay district does not ban
21	gasoline sensors.
22	MR. DELUCA: Absolutely correct. I'm
23	not suggesting also at the end of the day
24	that there is not going to be a fixed base

on it or at the airport.

1

2	All I'm saying is that there is clearly
3	a history at the airport. And at the airport
4	there wasn't enough attention being paid to
5	these projects when they came before the
6	County and the CEQ and the legislature.
7	These are outgrowths of that. As a
8	policy matter, it seems to me that there is
9	sufficient evidence that the public just
10	wants to know that the most careful
11	environmental analysis is being done.
12	The outcome will be what the outcome is
13	and the public will have to live with that
14	outcome. It lies within your hands to impose
15	the greatest level of scrutiny.
16	I think that there is a substantive
17	basis for it. And I'm not concluding ahead
18	of schedule that it's going to be approved or
19	that you will deny it or that it will be
20	one size or another size.
21	I do presume to know a little bit about
22	the review process. It seems to me that if
23	there is a potential that the project may
24	impart a single environmental impact of
25	

significance.

1	
2	Then there is an obligation by the lead
3	agency to require an environmental impact
4	statement whether it's a type one action or
5	not.
6	I think that's the basic objective here.
7	But I tried to support that with a
8	substantive basis as well as a procedural
9	basis.
10	MR. BAGG: One clarification on that,
11	Bob. If it becomes a type one action, it
12	requires a long term form to be filled out.
13	And it requires review of the project.
14	And parts two and three are to be filled
15	out. And basically if there is considered a
16	significant impact, it can then be evaluated
17	in a part three. It does not necessarily
18	require the protection of an impact
19	statement.
20 21	MR. DELUCA: Sure.
22	MR. BAGG: And I would say that probably
23	across the state 95 percent of type one
24	actions do not receive EAF.
:. TE	MR. DELUCA: Okay.

MR. POTENTE: Mr. Chairman?

102 1 THE CHAIRMAN: Yes. 3 MR. POTENTE: In regard to what Jim just 4 said. I would like to put a motion on the 5 floor that this be a type one action. 6 THE CHAIRPERSON: We haven't heard all 7 the public comment. 8 MR. POTENTE: I'm sorry. 9 MR. DELUCA: I'll get out of the way. 10 THE CHAIRPERSON: Thank you very much, 11 Bob. 12 MR. DELUCA: Thank you very much. 13 THE CHAIRPERSON: Our next speaker is 14 Gail Klyha. 15 MS. KLYHA: May I give you some 16 documents? 17 MS. VILORIA-FISHER: You just said that 18 if we take this up, a type one, that it 19 would require part two and part three. 20 Part three was done. 21 MR. BAGG: That's correct. As part of 22 the package. 23 MS. VILORIA-FISHER: That's why I read

MR. BAGG: Significant impacts were

the noise abatement.

2	noted. Other impacts were noted. Part three
3	was filled out to review those impacts and
4	whether or not they could be mitigated and
5	whether they would have significant impact
6	on the environment.
7	MS. VILORIA-FISHER: So if we were to
8	call this a type one, what else would there
9	be presented to us?
10	MR. BAGG: Well basically once the
11	action has been filed pursuant to SEQRA,
12	it can be that the type one which states that
13	the action is more than likely to have
14	significant impact and may require the
15	preparation of the GEIS, there are unlisted,
16	that requires preparation of forms EAF, parts
17	20 and 3.
18	MS. VILORIA-FISHER: But we have parts
19	two and three.
20	MR. BAGG: It's considered less of a
21	potential impact. And then you have type
22	two action. So the classification and the
23	action when it's unlisted as type one is not
24	necessarily, it doesn't mean anything

It's whether or not all the impacts were

1 104 covered and reviewed and is a negative 2 3 declaration supported or is further 4 information necessary for positive 5 declaration and preparation of a GEIS. 6 MS. VILORIA-FISHER: Okay. In layman's 7 terms what I am asking is that we have 8 already done some of the hard look because 9 they have given us parts two and three. 10 MR. BAGG: That's correct. 11 MS. VILORIA-FISHER: Okay. 12 THE CHAIRPERSON: Ms. Klyha. 13 have three minutes. 14 MS. KLYHA: My name is Gail Klyha. 15 Let me just first say the coalition against 16 the airport pollution is an appliance of 17 neighborhood and civic organizations. 18 They are united in concern about the 19 development, particularly Gabreski that lies 20 beneath it. 21 This airport as you know has been in use 22 for a very long time. And over the years 23 there has been quite a lot of damage done in

terms of fuel spills and other types of

contaminants being released and entering the

24

ground water.

The page that I have given you that runs horizontally is a summary of 18 such known or suspected contamination sites.

And obviously in two minutes we are not going to read all through this. But I would just ask you to take a look at some of the substances that have been released on top of our drinking water supply. The compound and things that I can't even pronounce.

When we think about cumulative impacts,

I would just like to suggest that you are not
talking virgin territory here. You are
talking about property that is already
severely compromised.

And I would urge that before any further aviation activity is permitted to expand here, you think about the harm that has already been done.

I would like also if I may, there was some discussion about the GEIS chemicals. I was not at the ACAP meeting but I was told that a representative from the Health Department was there and said that it's

1	
2	indeed a hazardous substance under Suffolk
3	County law.
4	If somebody at that meeting could
5	confirm that, Bob, is that correct?
6	MR. DELUCA: I don't know.
7	THE CHAIRPERSON: Your three minutes
8	are about up.
9	MS. KLYHA: The other thing quickly
10	that I would like to point out is that
11	although we have some very fine legislation
12	in Suffolk County regarding procedures that
13	are supposed to protect the ground water
14	supply, the fact is that these regulations
15	have barely been enforced.
16	And there is a document here with
17	excerpts from the County Health Department
18	inspections showing that both this applicant
19	and another fixed base operator at the
20	airport were not in compliance or did not
21	comply three years later when the inspector
22	came back.
23	Many things had still not been
24	corrected. In the case of Long Island Jet
25	THE CHAIRPERSON: Would you summarize.

2	MS. KLYHA: When the County threatened
3	legal action. So I think that you need to
4	examine not only the laws that are protecting
5	the ground water but what the record shows
6	about the enforcement of those laws and the
7	willingness of this particular applicant to
8	comply with them.
9	THE CHAIRPERSON: Thank you very much
10	for coming out today. We have a question I
11	think.
12	MS. VILORIA-FISHER: Yes. Thank you
13	for bringing these issues to our attention.
14	I have to be very honest and I don't see that
15	they are particularly germane as to what our
16	decision is today.
17	But I do believe that they are very
18	important that this information be brought
19	before the Legislative Committee that
20	oversees health issues.
21	MS. KLYHA: Right.
22	MS. VILORIA-FISHER: And that you bring
23	those to the Legislative Health Committee
24	meeting, Health and Human Services Committee.
25	MS. KLYHA: Right.

25

2	MS. VILORIA-FISHER: These are process
3	issues that have to come before the
4	legislature or the County Executive.
5	MS. KLYHA: Thank you. I appreciate
6	that suggestion. I guess my thought was
7	that this is kind of background that perhaps
8	would be germane to you in deciding what
9	level of environmental review the particular
10	application should have.
11	MS. VILORIA-FISHER: Even if they were
12	to be given the SEQRA approval and there were
13	no oversights later on and there weren't
14	clear processes in place for our Health
15	Department to follow or if in fact they
16	developed the ball on those, then it's futile
17	to make any kind of environmental decision at
18	the outset if it's not going to be followed
19	up in future procedures.
20	MS. KLYHA: Sure.
21	MS. VILORIA-FISHER: So I think that it
22	would be really helpful if you went before
23	the Health Commission with this information
24	and you let the legislature know.

ACCURATE COURT REPORTING

MS. KLYHA: Yes.

_	
2	MS. VILORIA-FISHER: Thank you very
3	much.
4	THE CHAIRPERSON: Does anyone else
5	want to speak on this issue?
6	(None.)
7	THE CHAIRPERSON: Okay. I'll open
8	the floor for discussion.
9	MR. KAUFMAN: I'm looking at the
10	new information that was submitted to
11	us as to the new numbers. And I am
12	also confident that John wanted to try and
13	make this a type one.
14	You have to go by the acreage as an
15	initial question over here as to what
16	we type this as. And SEQRA is pretty strong
17	the case law is pretty strong in saying that
18	if it's not ten acres it's not ten acres.
19	You can't make your standard on
20	something like that. You know, it may
21	approach ten acres. It may get very, very
22	close.
23	But the case law does say that if it's
24	not ten it's not ten. And a lot of towns
:5	have been, a lot of the developers have been

1	
2	able to get in frankly under that particular
3	standard.
4	So ten is what the State has set up as
5	the standard. Functionally I don't see that
6	much of a difference between the type one and
7	an unlisted.
8	I am fully cognizant that a type one
9	more often than not has a presumption in it
10	that a pos dec could be issued. And that is
11	I think the question.
12	But I think that we are all asking the
13	wrong question here. The question I think
14	was not properly raised given the context of
15	all the laws that we have here.
16	Obviously we have to type it. But the
17	proper question is whether the proposed
18	action meets the master plan criteria and not
19	whether it's a pos dec or neg dec.
20	The proper question is when you have a
21	master plan that has been adopted and it's
22	got a negative declaration and it provides
23	for growth in there, individual later
24	projects that are undertaken as part of that
25	plan, I use the word "presume", are given a

1 112 2 neg dec only if they form the mandates of the

program.

The only pos dec is if it fails to conform to the master plan or raises an issue. As such only several questions are really possible here in this context given all the plans that would adopt the master plan, the pine barrens, et cetera.

Once a policy choice is made in the master plan, that guides what we are allowed to ask. The basic questions are does the basic project conform with the master plan.

Does the project have any plans that have not been considered or planned for.

A master plan is like a GEIS. It gets a neg dec. As I said, we got the '90 master play. That has a neg deck on it.

We have the master plan. We have the STPA. We have Southampton's plan as a receiving area.

The plans all say growth in an airport is okay. And in fact growth is directed towards that area.

The 1990 plan again provides for more

2	hangers in this area. There are no limits on
3	fuel storage. There are no limits that might
4	indicate these plans are somehow outdated.
5	Again the growth issue is specifically
6	considered in each of these plans. It's
7	specifically authorized.
8	Now I think that our question here that
9	we can ask is whether this action is in
10	conformance with the zoning and the planning
11	that's been established here.
12	I will say or state for the record that
13	I have seen SEQRA challenges to this kind of
14	a master plan and most of them plan when the
15	master plan has been properly adopted.
16	The master plans fail when they are not
17	properly adopted in a procedural sense. But
18	in a substantive sense they are usually
19	upheld.
20	Policy changes as to whether we want to
21	see or not see growth in the airport, that's
22	a whole different question for me.
23	I think at this point and time this
24	Board is guided by what is in place. If this
25	was a new plan, if we didn't have anything

1	
2	over there, my answer might be different.
3	My answer might be that this might be a
4	pos dec or something like that because we are
5	close to the pine barrens and we are close to
6	this and close to that.
7	And you have got to be very careful in
8	this kind of an area. We've got the pine
9	barren plans in the area.
10	But again we are dealing with an
11	existing airport and existing plan. And I
12	think that our real charge here is very
13	unfortunately circumscribed in that sense.
14	MS. VILORIA-FISHER: Make a motion?
15	MR. KAUFMAN: I wanted to throw that
16	out to the members before I said anything.
17	THE CHAIRPERSON: Are there any other
18	comments?
19	(None.)
20	THE CHAIRPERSON: I'll take a motion.
21	MR. KAUFMAN: To get this out onto
22	the floor, I will make a motion that this
23	is an unlisted action with a negative
24	declaration.
25	MS. VILORIA-FISHER: I'll second it.

2	THE CHAIRPERSON: We have a motion and	
3	a second. All in favor?	
4	(Aye.)	
5	THE CHAIRPERSON: Opposed?	
6	(Two opposed.)	
7	THE CHAIRPERSON: Three to two.	
8	We are now open for discussion. I wanted to	
9	discuss it.	
10	MS. VILORIA-FISHER: I wanted to discuss	
11	it too.	
12	THE CHAIRPERSON: Withdraw the vote.	
13	It's okay with me. Can we add conditions?	
14	MR. BAGG: Sure.	
15	THE CHAIRPERSON: I would make a motion	
16	then that the best I can tell is that despite	
17	the fact that the motion passed, there are	
18	some conditions that ought to be considered	
19	when this project moves forward if it indeed	
20	essentially does move forward.	
21	In particular I am concerned with the	
22	storage of fuel and whether its procedures	
23	that had been suggested are adequate.	
24	I am also concerned about the storage	
25	water runoff calculations and how they are	

	Τ.	
P	2	going to deal with that in the coming years.
	3	And I think that those are things where
	4	I want to see that we do in fact put some
	5	conditions on what this project eventually
	6	does.
	7	MR. KAUFMAN: Mr. Chairman, my mind was
	8	working the exact same way that yours was.
	9	I'm worried about the rainfall.
	10	Two inches is not something that I'm
	11	entirely comfortable with. I would like to
	12	see a higher rainfall capacity installed.
*	13	I do note that the rainfall is going to
)*	14	be caught one way or the other. This is not
	15	an area where the water flows away from or is
	16	relatively flat.
	17	But I would like to see the catch basins
	18	accommodate a three and four inch rainfall.
	19	I am also a little bit worried about the
	20	deicer in there.
	21	I would like to have that particular
	22	aspect of things run by the Department of
	23	Health to see if the DOH wants to have some
	24	
1	25	sort of a catch system and catch return if

you will.

2	THE CHAIRPERSON: Despite all the
3	good things about being able to use this
4	material and food products and so forth,
5	having worked on projects in Jamaica Bay, I
6	have to say that deicers are not really
7	compatible with the environment.
8	And that we should do the very best that
9	we can to capture them and if possible
10	recycle them.
11	MR. POTENTE: I make a motion to close
12	the meeting.
13	THE CHAIRPERSON: We have another issue.
14	MR. POTENTE: I'm okay with that.
15	THE CHAIRPERSON: Thank you. And, Jim,
16	can we go ahead and draft some conditions
17	that will be put on this issue?
18	MR. BAGG: Yes. It can become part
19	of the neg dec.
20	THE CHAIRPERSON: I that okay with
21	everybody?
22	MS. VILORIA-FISHER: I had thought
23	that we were breaking up the question.
24	There were a couple of things that I wanted
25	to sav.

2	Any reason for supporting the neg
3	dec is that although we are going to have
4	a larger capacity in our fuel tank, I
5	believe that the issue that was presented
6	by the group was that that would result
7	in a fewer fuelings, refuelings.
8	It would require fewer instances
9	of refueling. And that's usually when
10	you have the greatest potential of
11	introducing these chemicals to the
12	environment. As I say, refueling instances.
13	The other is that I believe one of the
14	other issues that was brought up is that if
15	you could have a larger tank and you have
16	less truck traffic with tanks coming in for
17	the refueling. So you would actually
18	mitigate some of the traffic issues with
19	regard to trucks.
20	I believe that safety in an airport
21	is very important. And crowding could be a
22	problem.
23	And we have to keep an eye on what kind
24	of introduction of air traffic results in or
25	the County has to keep an eye on that. Thos

1	
2	are policy issues.
3	So I feel fairly comfortable with the
4	presentation. And I believe that we have
5	listened to the community and the County has
6	paid attention to what the community has
7	said. And we responded to that. Thank
8	you, Mr. Chairman.
9	THE CHAIRPERSON: Thank you. Are there
10	any other comments?
11	(None.)
12	THE CHAIRPERSON: Okay. So we'll move
13	ahead and we'll draft some conditions as far
14	as the negative declaration.
15	Next on the agenda is the Police,
16	Smithtown Police Department. Bear with us
17	one moment.
18	Just for the record, Ms. Stiles has
19	rejoined us after recusing herself from the
20	last discussion.
21	MS. VILORIA-FISHER: Can I just say
22	something while they are setting up?
23	THE CHAIRPERSON: Sure.
24	MS. VILORIA-FISHER: This will be the
25	

first project to be built for the Precinct.

2	I have been waiting a long time to see that
3	law be utilized.
4	I worked hard to get that passed. And
5	it's been a while since it's been passed.
6	So, Mr. Chairman, I just wanted to ask
7	if at some future meeting it could be put on
8	the agenda instruction to CEQ on some of the
9	criteria for the buildings.
10	And perhaps Joe Schroeder who is in the
11	legislative review office as our energy man
12	could come and give a presentation on the
13	criteria.
14	Because when we review the final
15	building project, we will have to incorporate
16	some of the green building criteria in our
17	determination.
18	MS. SQUIRES: Are those standards
19	available?
20	MS. VILORIA-FISHER: I thought they are
21	without a doubt listed in the building
22	council.
23	MS. SQUIRES: What we adopted under the
24	resolution is part of the attendance of what
25	I introduced regarding the green buildings of
	-

Т	
2	Suffolk County. And it's under my
3	legislation.
4	THE CHAIRPERSON: Ms. Stiles.
5	MS. STILES: Was there a law passed
6	in Suffolk County that this type of project
7	is going to have to obtain recertification?
8	MS. VILORIA-FISHER: Yes.
9	MS. STILES: I'm sure that the project
10	applicant will explain this further. But
11	I thought that from reading it that it comes
12	pretty close but it doesn't actually obtain
13	certification.
14	MS. VILORIA-FISHER: I didn't read that
15	part. It has to achieve certification.
16	MS. STILES: I guess we'll discuss that
17	issue.
18	MS. VILORIA-FISHER: And we will have
19	something to talk about, recertification
20	standard. We need someone from our budget
21	review office.
22	THE CHAIRPERSON: Go ahead.
23	MR. LARSEN: I'll get started.
24	THE CHAIRPERSON: Identify yourself.
25	MR. LARSEN: My name is Keith Larsen.

2	I'm the Assistant County Architect for the
3	Department of Public Works and the project
4	manager on this project.
5	Before I introduce everybody that is
6	sitting beside me which is the members
7	of the design team, I would just like to say
8	that we are very excited to be here at this
9	point.
10	Because this does represent the progress
11	that we are making toward completing the last
12	of the police precincts, major renovations
13	and/or reconstructions.
14	If you recall, a couple of years ago we
15	did the 6th Precinct in Selden. That was
16	very successful.
17	This is a similar building in size and
18	requirements including parking and so on.
19	And our consultants will illustrate that with
20	their presentation.
21	I would just like to say that we are
22	also excited about the lead aspect of the
23	project. And we have incorporated a lot of
24	stainable design items into the building as
25	well as green building technologies which are

Ţ	
2	summarized in your handout, at the end of
3	your handout.
4	It is a point system and we have
5	designated several points in order to meet
6	the minimum recertification without actually
7	having to go to the green building council to
8	have it certified.
9	MS. VILORIA-FISHER: And if I could just
10	answer Ms. Stiles's question regarding that.
11	So, Lauren, what we did in my legislation was
12	that we would have to be able to achieve
13	recertification to the point, get the number
14	of points that would be required.
15	But we wouldn't go through the
16	application process, through the United
17	States Building Council to get the official
18	lead certification.
19	That we would get the points that would
20	allow us to achieve that. But we wouldn't
21	have to go through the process. And I think
22	that clarifies that question. Thank you.
23	MS. STILES: Can I ask a follow-up
24	question on that?
25	THE CHAIRPERSON: Yes.

2	MS. STILES: I am not criticizing it.
3	I think it's great that it's going in the
4	direction that the legislature would pass.
5	But on the bottom of the page it says
6	a lead certification requires at least 26
7	points. And this one right now only has 24
8	points and there's 22 likely.
9	I'm just trying to make sure that we are
10	on the same page. I just want to know where
11	you are getting those extra two points from.
12	MR. LARSEN: I'll let the consultant
13	answer that question once we get into that.
14	But we have identified points that we will
15	definitely be taking.
16	And then we have 22 additional possible
17	points. So we have the potential of getting
18	30 to 40 points on this project and exceed
19	the minimum standard.
20	MR. KAUFMAN: Just for the record,
21	Gloria Russo asked me to place this on the
22	record today. She noted the same thing that
23	you see, Lauren. And she was going to be
24	bringing up some of the points too.
25	MR. LARSEN: Now strictly the budget

1.	
2	project is 14 and-a-half million dollars. In
3	addition to that, we received a \$600,000
4	grant from LIPA for a photo voltaic system
5	which is a solar panel system which will
6	generate electricity.
7	And that's being incorporated into the
8	building. And in fact we would get a lead
9	credit for that.
10	Just very quickly. The site selection
11	for this building was determined by several
12	factors. And one being that it's a very
13	large vacant site located within the North
14	County Complex where we are today.
15	It's just east of the legislature
16	parking lot. And it is a quite visible site
17	in terms of police access. And it was
18	something that was expressed by the police
19	that they would have a presence on the site.
20	The other item is that being put on this
21	campus we wouldn't need to install another
22	fueling facility similar to those that are at
23	the more remote precinct sites.
24	This saves us money and it also saves us
25	a potential for any type of environmental

1	
2	spills.
3	And the other thing was that, and there
4	are several other utilities on site such as
5	the sewer plant which will support this
6	construction.
7	So with that said, we feel that it's a
8	very good project for the environment. It
9	has very low impact on the site here.
10	And we will get more into that in our
11	discussions. And from here I'd like to turn
12	it over to the consultant and the lead firm
13	of the Baldasano Architectural Group along
14	with their consultant Emtec Consulting.
15	They are mechanical electrical engineers who
16	are lead certified.
17	We also have representatives from McLean
18	Associates who spoke previously. They are
19	doing our site civil package.
20	And we have a representative from Steven
21	Winter's firm which is a nationally
22	recognized firm that deals with the lead
23	component of our project.
24	So with that said, I'd like to hand
25	the microphone over to Alex Badalamenti from

1	
2	the Baldasano group.
3	MR. BADALAMENTI: Good afternoon. My
4	name is Alex Badalamenti. I am a principal
5	at Baldasano Architecture.
6	I am here with our founding principal
7	Charles Baldasano and with Phil Monastero.
8	The three of us will make the design
9	presentation.
10	And as Keith mentioned, we do have other
11	consultants available for questions and
12	answers if they come up.
13	First of all we'd like to applaud
14	Legislator Fisher for the initiative taking
15	placing here. We'll try to be brief here.
16	But we are very compassionate about the
17	building, about the design and also I believe
18	initiatives that are part of this project.
19	It's a good thing for the County. And I
20	believe that it is the flagship for the
21	County initiatives.
22	As architects working on Long Island, we
23	have a 33 year history. And we are dedicated
24	to quality architecture on Long Island.
25	I won't go into the project but for the

2	County we just finished the Civil Court in
3	Riverhead which is a great success.
4	The site as mentioned is the new
5	construction of a new 4th Precinct for
6	Suffolk County Police. The site plan shown
7	in front of you is the County owned land
8	called the North County Complex which
9	comprises approximately 67 acres.
10	I'm outlining it in yellow. On the left
11	hand side is Old Willets Path. It's bounded
12	on the west.
L3	To the north it's bounded by residential
L4	districts. To the east is the County owned
L5	sewerage treatment plant.
1.6	Further to the east of that is
L7	Blydenburg Park. And to the south is Vets
L8	Highway, Nesconset Highway running along the
L9	southern portion.
20	In siting the building we are very
21	conscious of working with the police. The
22	location of this building not only to the
23	context of completion but also towards
3.4	visibility to the police as Keith mentioned

earlier.

_		-
2	0	There are approximately 22 buildings on
3		this site. Our particular site and location
4		is approximately 3.2 acres of affected land.
5		We have located the building at the
6		southeast corner of the site in red. The
7		Police and the County were very concerned
8		with access in and out of the complex for the
9		police. Also relieving the traffic on Old
10		Willets Path.
11		We were also concerned with the
12		visibility as mentioned about not only of the
13		police seeing the community but also the
14		community seeing the police. We think that
15		it's a very good statement for the County,
16		the security and it's a safe zone.
17		The alignment of the building, we have
18		taken into account the context of the site.
19		To the west and the southwest further over is
20		the existing clinic building.
21		In the middle is the existing, where we
22		are today in the legislative building. And
23		to the east our building.
24		We have aligned all three buildings so
25		that we continue the original master planning

2	emphasis on the street front that's there.
3	The southeastern corner we have also
4	been very conscious of the grading in place
5	and the trees and maintaining as many trees
6	as possible. We have designed the building
7	and parking around the significant trees in
8	that area.
9	The eastern access road which I believe
10	is called County Route Road or North County
11	Extension, a couple of names, that will be
12	the major ingress and egress to the site.
13	This illustration was our original
14	concept drawing for the building. What is
15	important is that it's borne out of the
16	landscape.
17	We are very conscious of the visibility
18	of the building but also the surrounding
19	context of the trees, the natural landscape.
20	As architects living and working on Long
21	Island, we are also very concerned about our
22	natural environment and priorities. We
23	worked with the grading of the building.
24	We have earth bermed the lower levels of
25	the building also for the advantages. And

1	
2	the orientation in an east-west direction of
3	the building gives better exposure to the
4	north and south of the building or lead
5	initiative.
6	With that I'm going to pass to Phil who
7	is going to go through the current design of
8	the building.
9	MR. MONASTERO: My name is Phil
10	Monastero. As was just pointed out, the
11	design of the buildings really center around
12	the site and the environmental issues that i
L3	tries to control.
14	And really once you enter the site off
L5	the east road access, our main entrance will
L6	be off the campus road.
L7	It would bring the public into a parkin
L8	area in our northeast corner of our site. S
L9 _	at the face of the building the entrance wil
20	actually face the campus on the campus road.
21	When the public drives in, they will se
22	the entrance. As soon as they drive in, the
23	will be able to drive onto the site going
24	

1	
2	there is an opportunity to use overflow
3	parking on the north and a walkway in case
4	that parking area gets crowded from the
5	public.
6	But the site that was mentioned is
7	designed and the building, I'm sorry, is
8	designed on the east-west access.
9	So it's a rectangular building allowing
10	a more southern and northern light to enter
11	the building. And having less light on the
12	west side which will increase.
13	One of the parameters that we started to
14	design was a parking area on Vets Highway to
15	maintain a 60 foot setback off Vets Highway
16	and also maintaining as many trees as we can
17	on Veterans Highway. I'm asking at the same
18	time to shield the parking from Veterans
19	Highway.
20	The lower right hand corner of the
21	entrance, the southwest corner of the site is
22	going to be graded so that the building will
23	look like it starts to draw itself out of the
24	landscape. That will mainly landscaped.

We are going to prune some of the trees

1		13
2	there to get the visibility of the building.	
3	But the building will really look like it's	
4	in a wooded area from Veterans Highway.	
5	The parking area that surrounds it is	
6	also for police for their detectives and	
7	administrative use and also the crime unit	
8	patrol cars will be parked there. And you	
9	can see the parking area just to the west	
10	will remain intact as is.	
11	Just briefly I'll show you the floor	
12	plan. This is the main floor plan where the	
13	main entrance is on the north side entering	
14	the main desk area.	
15	And to either side will be the criminal	
16	processing which will also be on the ground	
17	floor.	
18	What is interesting about this is that	
19	you will see the administrative areas and	
20	detectors will have south facing areas. They	
21	will have views to the outside.	
22	We'll go to the lower level. The	
23	concourse area has not only mechanical rooms	
24	and lockers but also an exercise room and a	
25	lunch room.	

1	
2	Those two rooms will open directly
3	to that lower area on the southeast corner.
4	That is going to be landscaped.
5	Those two rooms, the exercise room and
6	the lunch room, will get some light as well.
7	They will have views onto that area.
8	Then the second floor comprises of
9	community areas, community meeting rooms and
10	the commanding office and administration
11	rooms. Again south facing glass allowing
12	views to enter.
13	One exciting part about this is that
14	this main desk area will be open to the
15	second floor as well. So that the views, the
16	sunlight will start to come into the building
17	and penetrate the interior of the building.
18	So that all the rooms around that
19	interior main desk will be flooded with
20	sunlight. And we feel that that's part of
21	the initiative.
22	We are trying to create an
23	environmentally gengitive building ag well ag

We are trying to create an environmentally sensitive building as well as the interior workings. People that work in this building will be able to see each other.

24

2	There will be staircases that they use
3	and light will really flood itself into the
4	entire area.
5	As we start to look at the elevations,
6	I'm sorry, the roof plan is where we start to
7	see. There will be a penthouse with
8	mechanical equipment. All of this area on
9	the roof will be used for mounting of the PB
10	cells.
11	This way it uses the roof and it's also
12	going to be visible from the road. And we'll
13	show you that in a second.
14	The elevations, this is the south
15	elevation where there is glass in that little
16	area where the light will start to get into
17	the main desk area from the second floor.
18	The other areas are administrative.
19	This is that south area that's in the lunch
20	room and the exercise room on that corner as
21	soon as you enter the building.
22	But we are trying to create a building,
23	I'm sorry, PB cells are located. They will
24	be visible from the roof.
25	And the whole building, what we are

2	trying to do is being sensitive to the campus
3	and the building that we are trying to create
4	is visibility on Veterans Highway.
5	We are trying to use the materials that
6	are also on the campus by using brick and
7	glass and metal. We feel that the building
8	should somehow relate to its context but at
9	the same time kind of stand separately as the
10	building of this lead initiative. And we
11	really wanted to use materials that kind of
12	emphasize that.
13	You see on the north side now that it's
14	a two story element. This is a brick facade.
15	The main entrance will be here.
16	And what is not shown in here is the
17	trees and the vegetation that will really
18	kind of also frame the building.
19	You can see that the west elevation has
20	less glass. And the brick will start to
21	relate itself to the legislative building.
22	Then here you see some of the images
23	that the view of our top is a view from the
24	entrance drive in from Veterans Highway.
25	This is at the southeast corner. The

2	lower level of the exercise room and the
3	lunch room, the administrative offices, the
4	drill and detectors on this floor and the
5	central atrium into the main desk area.
6	It's all being driven by the
7	landscaping. I'm sorry, the solar screening.
8	We are providing a solar screening to
9	reduce the light on the administrative areas.
10	So we are using materials and techniques to
11	reduce heating as well as make this building
12	really feel like it's part of the environment
13	and part of the landscaping.
14	As you can see from the roof here, the
15	PB cells are on top. The building, but also
16	breaking down the composition of the
17	building, one and two stories, the volume
18	that will be seen from the campus kind of
19	breaks down the mass of the building.
20	You can see here how it will grow out of
21	the landscaping on the southeast side. The
22	parking will be shielded from trees and the
23	trees are in the back grouped.
24	There are two major trees that we are
25	maintaining and keeping on the site. So it

1		13
2	will be framed by those trees as well.	
3	And of course we have an animation.	
4	Hopefully we are not driving too fast when	
5	you see that. And there will be a lot of	
6	trees especially in this area.	
7	MR. KAUFMAN: I have a question.	
8	One quick question of the two big oak trees.	
9	MR. MONASTERO: Yes.	
10	MR. KAUFMAN: Are those going to be	
11	within the fall zone of the building? In	
12	other words, if branches start breaking off,	
13	are they going to collapse?	
14	MR. MONASTERO: No. If you look at the	
15	site plan, let's go back to that. We have	
16	created islands around those trees.	
17	And we have tried very hard to stay away	
18	from those trees in any way that is	
19	detrimental to the trees or buildings. I	
20	don't know how far a branch will fly.	
21	MR. KAUFMAN: It's flying vertically	
22	as opposed to horizontally. I just went	
24	through that at home. So I'm kind of	
25	cognizant of it.	

MR. MONASTERO: There are no windows

.1.	-
2	on that side on the lower level anyway.
3	But we took those trees into great
4	consideration when we designed this.
5	MR. KAUFMAN: Thank you.
6	THE CHAIRPERSON: I have a question if
7	you don't mind with regard to overall effort.
8	I'm sure you're all well aware that police
9	buildings get an unusual amount of wear and
10	tear.
11	And I guess I'm concerned that you're
12	doing all these wonderful things for a
13	building that would be a great office
14	building.
15	But is the utility of this building
16	being compromised so that, you know, six
17	months after the building is opened the
18	various materials are starting to be shredded
19	just because of the nature of the work that's
20	there?
21	And secondly, these buildings are
22	designed for an atmosphere at the time of
23	construction. And government has a very bad
24	propensity for no sooner than you move in you
25	

start reallocating space.

2	And so that the original design concept
3	to conserve energy, to conserve heat and so
4	forth is certainly out the window. And you
5	have a box that is no longer efficient at any
6	length.
7	And I'm just wondering, do we have a
8	commitment from the legislature that there is
9	going to be some light on how this building
10	is going to be torn apart in the future?
11	And, you know, sort of practical questions.
12	MR. MONASTERO: Well when we designed
13	the building, it's with the use of the
14	interior partitions. Concrete block walls
15	are painted block walls.
16	So the interior of the building will
17	maintain its durability. And we have
18	designed that into it as well as using green
19	building materials, carpeting and tile and
20	paint and things like that.
21	They are still green and yet durable.
22	The essence of the building though, the
23	inherent part of the building can't really be
24	altered in terms of the atrium and the

exterior materials.

2	I mean, inside they are flexible enough
3	to change. But I think inherently built into
4	our designs are other systems that really can
5	accommodate a lot of different uses.
6	But I don't think that the building
7	itself would change. And we would really, I
8	mean, the DPW gave us a list of
9	specifications and we maintain that finish.
10	MR. KAUFMAN: I think your safest course
11	would be to not allow CEQ to be there.
12	THE CHAIRPERSON: Thank you.
13	MR. BALDASANO: Charles Baldasano.
14	I just want to take the opportunity to thank
15	you for presenting this exciting project.
16	As you can tell, this is multifaceted.
17	There are a lot of issues that we had to deal
18	with.
19	And certainly the most prominent are
20	leads processing and being sure that we
21	incorporate as many of these elements as
22	possible.
23	And you can hear the description and
24	passive solar energy and active solar energy,
25	mechanical systems taking full advantage of

1		14
2	the nature of the site.	
3	It is a flexible building in the sense	
4	of interior partitioning that is able to be	
5	relocated to some degree.	
6	There are some as Phil described block	
7	walls and permanent construction. But it is	
8	flexible to that degree.	
9	Because in the 21st century design we	
10	have more free stand and open stand	
11	structures allowed for flexibility.	
12	Do we foresee with the County in the	
13	future it being a totally different building	
14	and use? That's hard to predict.	
15	But the very nature of the building is	
16	to be very sensitive to the environment. And	
17	that really was our charge.	
18	And we thank you again for the	
19	opportunity of presenting it. We have	
20	several experts here for Q and A. And we	
21	invite your questions.	
22	THE CHAIRPERSON: Are there any	
23	questions?	
24	MS. STILES: Yes. The larger square	
25	like aspect of the building on the east side.	

142 1 I want to mention that it was solar 2 3 screening. Is it a screen over windows or 4 cement? I'm not sure what it is. 5 MR. BADALAMENTI: It's a stainless 6 steel mesh on the building. And it's over 7 an insulating glass curtain wall system. 8 So it's energy efficient plus it cuts down 9 the solar gain. 10 MS. STILES: You can see? 11 MR. BADALAMENTI: Absolutely. 12 transparent. It's actually translucent. 13 MS. STILES: I worked in a County 14 office building. 15 MR. BADALAMENTI: In this case a 16 shading. 17 THE CHAIRPERSON: Mr. Kaufman. 18 MR. KAUFMAN: I'm concerned about the 19 parking on the south side of things. 20 I'm looking at the legislative block. 21 And to my memory it's usually not very 22 jammed. The working legislative lot is 23 pretty jammed.

My question was going to be, if we could 25

24

see our way clear to maybe not having the

1	
2	parking on the southern side, the 46 spaces,
3	and possibly having the overflow parking.
4	But that may not be possible.
5	MR. LARSEN: Yes, I would like to
6	answer that. Basically the program is
7	150 spaces. We could only fit 118 on site
8	with the constrictions of the actual piece of
9	land.
10	So there is a large requirement for
11	police parking. It's their personal vehicles
12	plus squad cars.
13	We envision the personal vehicles to be
14	on the south side which would be a more
15	secure lot for the police.
16	That was a concern of theirs as well as
17	we didn't want to overlap with the
18	legislature lot.
19	Because we felt that, you know, although
20	it does not get used all the time to its
21	capacity, it's there and it was designed for
22	the legislature.
23	And that if we did need any additional
24	spaces, we would locate them across the way
25	on the other side of the road by the Labor

2	Department buildings.
3	There are also several divisions. There
4	is a detective division which is located on
5	the north side. And there was also public
6	visitor spaces located there as well.
7	So if we did need any additional parking
8	which at certain times we could need an
9	additional public usage that they could use
10	the lots across the street and certainly walk
11	across the street and down the main path to
12	the entrance of the building.
13	We didn't really see any way of
14	relieving the site of potential parking. To
15	the degree that we also did not want to
16	impact the whole side and tear out all the
17	trees.
18	I mean, we are very sensitive I believe
19	to that aspect of it. There will be quite a
20	large buffer there still if you are going
21	down Vets Highway, especially heading east.
22	You really won't see the building until
23	you really get right at the corner of the
24	site, even in the wintertime.
25	Because there a lot of evergreens in

2	that area and there is a lot of underground.
3	So we are very sensitive in maintaining and
4	preserving those areas.
5	THE CHAIRPERSON: Thank you.
6	MS. VILORIA-FISHER: I have a couple
7	of questions. Are there any ventible or
8	windows that open?
9	MR. LARSEN: Not at this time.
10	MS. VILORIA-FISHER: That's too bad.
11	THE CHAIRPERSON: The criteria. The
12	lead criteria.
13	MR. LARSEN: Part of it was security
14	also I might add.
15	MS. VILORIA-FISHER: Security?
16	MR. LARSEN: Yes.
17	MS. VILORIA-FISHER: With regard to
18	commissioning, would that be Emtec Engineers?
19	Would they have the commissioning piece?
20	Who is doing the lead training of County
21	people and who would be involved in the
22	commissioning?
23	MR. LARSEN: Well we are going to
24	be hiring a commissioning agent through
25	our project manager who is the firm of

2	Cashin Associates.
3	MS. VILORIA-FISHER: So it's not any
4	of the people that you have already
5	mentioned?
6	MR. LARSEN: No.
7	MS. VILORIA-FISHER: Okay.
8	MR. LARSEN: We in the Department of
9	Public Works have received some training,
10	you know, through the consultants. But
11	that's one of our goals is to be more
12	educated in that area. Being that my large
13	project that is going forward is also going
14	to have to be received favorably.
15	MS. VILORIA-FISHER: Just so I know.
16	The 4th Precinct was supposed to be a
17	pilot project. But it took so long that
18	I went ahead and did the rest of the lead
19	regulations.
20	Because we just couldn't keep waiting.
21	We were supposed to be groundbreaking.
22	In any case, the original legislation
23	did call for training of people in the County
24	and in the lead criteria. So that has been
25	going on?

going on?

2	MR. LARSEN: Yes, that is correct. We
3	are arranging for several seminars from the
4	Steven Winter's firm here being represented.
5	And it is our goal to have several
6	people in our office to be lead certified.
7	And we also have an energy engineer in our
8	office. That is Javad Ashram.
9	MS. VILORIA-FISHER: Is he a County
10	employee?
11	MR. LARSEN: Yes. He's under Tom
12	LaGuardia's facility as engineering. So we
13	are very familiar with the principles of the
14	lead system.
15	All of us in our office since we are
16	headed that way, I'm going to try to obtain
17	some type of a certification so that we can
18	deal with it individually.
19	MS. VILORIA-FISHER: Okay. Are we now
20	members of the U.S. whatever the council is?
21	Do we have membership? Because I know that
22	there was a little problem.
23	MR. LARSEN: I am not sure of that.
24	I will check on that when we get back to
25	the office.

2	MS. VILORIA-FISHER: It's just easier
3	to access all of the information and lead
4	has changed in the years that I have been
5	working on this and criteria have changed.
6	What are we up to now, lead four?
7	Do you know? When I first introduced, I
8	think I introduced the legislation and we
9	were at lead two.
10	MR. LARSEN: We were doing 2.1 and
11	I know that it has changed and upgraded each
12	year. And I guess as per the legislation we
13	are going to keep referring to the 2.1 unless
14	something else changes to amend that.
15	MS. VILORIA-FISHER: I would just like
16	to know that the Department of Public Works
17	is aggressive in whatever new changes they
18	are making.
19	MR. LARSEN: We are aware of the
20	changes, yes.
21	MS. VILORIA-FISHER: Okay.
22	THE CHAIRPERSON: Yes?
23	MS. STILES: I just have a question.
24	I'm looking at, there's a little annotation
25	on page 2 of the summary charges. It says

-	
2	November 16th.
3	It indicates desire for exterior
4	lighting. I'm not sure who that email came
5	from. But that's something that I think
6	would be great for the type of building.
7	And I understand that the primary
8	purpose of the building is to use, security
9	has to be the number one concern. But I am
10	not really sure.
11	It says after that the high level
12	lighting for security will most likely not
13	comply with this credit. But I'm not sure
14	how full cutoff lighting can't provide high
15	level lighting.
16	I think that maybe there's some
17	confusion that full lighting has to involve
18	low lumens or low wattage.
19	As I understand it, full cutoff lighting
2.0	is not shining up on it into the outer space.
21	I'm pretty sure that criminals are not coming
22	from out there.
23	So I am concerned about the way that or
24	your designers could perhaps explain that or
25	look into that. That's a way to get credit.

2	MR. LARSEN: Yes. I have someone here
3	to shed more light on that so to speak.
4	But the County does have a very compliant law
5	which we do on every building project.
6	So that's something that is mandatory
7	that we do. But I'll hand it over to one of
8	the engineers to maybe shed some light on it.
9	MR. HIGGINS: My name is William Jose
10	Higgins. The name is Veridian Engineering
11	Environment, formerly a division of Steven
12	Winter Associates.
13	In direct response to that question, the
14	design team is doing as much as they can to
15	comply with the lead criteria for this credit
16	in that they are considering a full cutoff
17	fixture and so forth.
18	But there is a high level of lighting
19	required for this type of facility which will
20	most likely, I can almost guarantee, will not
21	get to all the levels.
22	Because there is also a level of not
23	just blocking the light pollution into the
24	sky, into the neighborhood. There is also a
25	maximum lighting on the gite itgolf that this

1		LO.
2	type of facility would be almost impossible	
3	if not very difficult to comply with.	
4	So the comment is basically saying, you	
5	know, they are looking at the full cutoff and	
6	they are trying to reduce the amount of	
7	pollution to the environment, to the air, to	
8	the neighbors and so forth.	
9	But the actual foot-candle levels on the	
10	site will most likely be above the maximum	
11	requirements by lead.	
12	So the credit won't be earned but they	
13	are going to go, you know, at least get as	
14	far as they can. And there's been a lot of	
15	lead credit that they may not be allowed to	
16	do. But they will try to do as much as they	
17	can anyway and that will be noted in their	
18	report.	
19	MS. STILES: But the footnote is not	
20	indicative that full cutoff cannot be used.	
21	It probably won't be met because of the	
22	wattage of too much.	
23	MR. HIGGINS: Exactly.	
24	MS. STILES: Okay.	
25	THE CHAIDDERSON: Vivian I have a

question. And this goes more to maintenance as opposed to construction.

MS. VILORIA-FISHER: Right.

THE CHAIRPERSON: But a number of the credits that we pick up on, in fact they depend upon the fact that originally they were going to put low flow water fixtures and they are going to have, again my concern goes to the County's commitment to enforce the use of these things and training of the people that are using the building to make sure that they understand why they are there.

And then as soon as one of them breaks down, it's not going to be re-piped for three gallons or seven gallons, et cetera. How do you handle that?

MS. VILORIA-FISHER: That's a really good question. It's something that I have been concerned about since I had been working on trying to get clean buildings.

That's why I asked DPW about having people for our County employees who are trained. I think that's why the commissioning process is important to have

people that are trained to maintain these systems the way they should be who will maintain through the regular maintenance according to standards.

And I have been assured by, well formerly by Charlie Baldasano that the County had been moving in that direction. Because we have had other pieces of legislation that had been moving in this direction.

For example, the use of green products or green cleaning products, different types of practices that we had that really have become best management practices in so many parts of the United States and other municipalities. Correct me if I'm wrong on any of this.

But I believe that because we are realizing a savings to the County in maintenance operations cost, because if there is a spike in construction, we will realize a savings in MNO through the years.

And there had been more and more studies indicating that when you use materials that aren't noxious to individuals that you have

2	better employee health and better employee
3	attendance.
4	I'm disappointed about the ventible
5	windows because I think that is something
6	that is very good for employee health.
7	But I assume that we'll have good
8	filtration in the systems. You know, there
9	is a problem in the 6th Precinct with some
10	mold in the downstairs level. It was a very
11	well insulated building.
12	Unfortunately people's leather jackets
13	were in the lockers downstairs. So I'm
14	hoping that we have those levels of
15	filtration that we should have.
16	Because again that's good for employee
17	health. So we not only want to protect the
18	environment. We want to protect the
19	environment of buildings for those people who
20	are spending most of their day in the
21	building.
22	So to answer your question, Larry, I
23	think that we are doing everything that we
24	can to make sure that we maintain an ongoing
25	consciousness of how our buildings are

2	operating over the long haul.
3	THE CHAIRPERSON: Thank you very much.
4	Joyce.
5	MS. SQUIRES: This is a question
6	regarding economics. And I think that it's a
7	public relations question.
8	Is there anything that is going to show
9	that this is economically advantageous to the
10	County to use lead standards for public
11	relations purposes for the County and then
12	say, look, we built this kind of building and
13	it was certainly environmentally sound? But
14	it was also economically sound.
15	And I would be very interested in
16	looking at that. If you could refer me to
17	something.
18	MR. LARSEN: Yes, I'd just say very
19	briefly that as part of the legislation we
20	have to report back to the full legislature
21	on I guess the results of the building.
22	In other words, prior to design being
23	completed and then after the building is
24	built and occupied.
2.5	

So we will have some direct information

Т	
2	on actually how we did in terms of energy
3	efficiency. And we'll see that, you know,
4	we'll see that in the bills that we get,
5	B.S. Oil and so on.
6	We can compare that to other similar
7	buildings that we have in the County.
8	We have been doing that type of analysis for
9	quite some time. And it is a little more
10	expensive to build a building of this
11	quality.
12	But overall in time the payback is
13	there. I'm not sure how many years that will
14	take.
15	But it's not only a cost thing. It's
16	also an environmental type, you know, of
17	factor which really you can't place a cost
18	on.
19	And I think that it's a good opportunity
20	for the County Executive to, you know, report
21	this type of issue to the public in that this
22	is the way that the County is headed in terms
23	of all the building projects in the future.
24	So I think that it's a very positive
25	thing for the County. And I applaud

.	-
2	Legislator Fisher for passing that
3	legislation and pushing for it.
4	I think that it's a very good thing
5	and the rest of the country has really gotten
6	on board with this.
7	THE CHAIRPERSON: Were you having a
8	lawn sprinkler system put in?
9	MR. LARSEN: Excuse me?
10	THE CHAIRPERSON: Will there be a lawn
11	sprinkling system?
12	MR. LARSEN: We will have a fire
13	sprinkling system.
14	THE CHAIRPERSON: Lawn.
15	MR. LARSEN: I'm sorry, lawn?
16	THE CHAIRPERSON: Yes.
17	MR. LARSEN: No, the County policy is
18	really no irrigation.
19	THE CHAIRPERSON: You're going to take
20	some of that effluent and sewage treatment
21	plant?
22	MR. LARSEN: We'll also keep all our
23	storage water on site rather than discharging
24	it to other systems on the campus that go

into, you know, neighboring ponds and things

2	like that:
3	THE CHAIRPERSON: Legislator Viloria-
4	Fisher.
5	MS. VILORIA-FISHER: I notice that
6	you have the carpooling parking spots that
7	are closest to the building. How much is
8	that being encouraged in a real way in the
9	Police Department? Do you know?
10	I mean, obviously you have been working
11	with the police officials. Do you know are
12	they going to be sending out memos to the
13	people and the police officers and clericals
14	in the building to try and do carpooling?
15	Is this going to really be pushed?
16	MR. LARSEN: I guess that's up to the
17	powers that be. I know County wide there was
18	a push for carpooling. And I'm not sure how
19	well it did.
20	But it's probably a little more
21	problematic for the police. Because they are
22	working different shifts. They are coming
23	from different areas.
24	It's really hard for me to comment on
25	that. You know, we will be a proponent of

1	
2	that.
3	However, I'm not sure as to, you know,
4	the full or what will manifest out of that.
5	MS. VILORIA-FISHER: I'm just asking
6	that we have a conversation with the Police
7	Department, with the administration, that it
8	be something with which they are coactive.
9	MR. LARSEN: Yes.
10	MS. VILORIA-FISHER: And I didn't
11	mention that it's written here. But there
12	are a number of buses that run right along
13	the front of where you will be putting the
14	building. And that's good for public
15	transportation and that gets points.
16	MR. LARSEN: Exactly. There is a bus
17	stop right at the corner now which is a
18	plus.
19	THE CHAIRPERSON: Thank you very
20	much. Ms. Stiles.
21	MS. STILES: I'll try and make this
22	quick. I did have a question about the
23	fueling station. I guess you will be
24	installing a new underground storage tank

in the northeast part of the property.

1	1	16(
2	Is that correct?	
3	MR. LARSEN: There is currently a	
4	general fueling station at the northeast	
5	area which is used by all County vehicles.	
6	Right now the police are using that.	
7	Since the 4th Precinct is presently on the	
8	same campus, you know, on the northwest	
9	side.	
10	. It was originally a fueling facility	
11	at the existing 4th Precinct which has	
12	since been shut down and the tanks have been	
13	removed.	
14	We are adding a generator to the fueling	
15	station so that if we do lose power there is	
16	always fuel there. We thought that was very	
17	important.	
18	MS. STILES: And since you are adding	
19	that, are you removing vegetation from that	
20	area at all?	
21	MR. LARSEN: No. It's actually an	
22	above ground tank. It has a small tank on it	
23	which will provide a certain amount of hours	
24	of operation.	
25	MS STILES. Okay I was asking that	

+		
2	because I'm sure you thought there is an	
3	endangered New York State species located	
4	sort of in the park area.	
5	And there is an Atlantic white cedar	
6	colony out on one of the islands. And	
7	I just know from experience that sometimes	
8	the natural heritage reports are close but	
9	not exact.	
10	And in the DEC letter it even says	
11	this information should not be subject to	
12	the site survey.	
13	And I was just wondering, has anyone	
14	from your team gone out there and just	
15	checked to make sure that the listed species	
16	of concern are not residing on the site	
17	where there is vegetation to be removed?	
18	MR. LARSEN: I could defer that to	
19	our site	
20	MS. STILES: I'm just asking about	
21	anyone.	
22	MR. SPEISER: Andrew Speiser. Our	
23	recommended architect inspected the site.	
24	Our landscape architect did not identify	
25	the nest species that the New York State	

1		1
2	DEC identified as being associated as	
3	habitat for that.	
4	MS. STILES: And he was looking for	
5	that when he was out there?	
6	MR. SPEISER: Yes.	
7	MS. STILES: The other question I	
8	have is on the lead summary chart, page	
9	four, energy credit six talks about that	
10	the County is currently buying green	
11	power.	
12	And the County may be able to earmark	
13	a small amount of that for this project to	
14	get the lead certification.	
15	I'm really glad that you are trying to	
16	get the lead certification. I kind of feel	
17	like it's kind of like cheating on taking the	
18	green power and allocating that to the	
19	project.	
20	They are not really offsetting anything.	
21	The non-green power will then have to replace	
22	whatever else in the County that green power	
23	was originally used. Is there any	
24	consideration by additional green power to	

meet the lead certification?

2	MR. LARSEN: That's a good question.
3	We had discussions on that. We are buying
4	green power. But we can't attribute it to
5	any specific, you know, building or anything
6	like that.
7	So we were toying with the idea of
8	if we take it we'll only take it once.
9	In other words, if we use it on this
10	building, that would be it.
11	We can't use it again on any other
12	building. Because again it is sort of like I
13	guess cheating. We may not take it at all.
14	It was a possibility.
15	It's still up for discussion. Our
16	engineer in our office didn't think that it
17	was, you know, a viable credit. But we
18	haven't finalized a list of credit yet.
19	MS. STILES: I mean, if there is a way
20	that you can figure out an energy budget for
21	the building to sort of just ask the County
22	to buy that much more green power.
23	It's something that you can allocate to
24	that building. That seems like a good way to
25	get the credit.

2	MR. LARSEN: That's definitely a
3	possibility. We are going to look into that.
4	Right now the consultants are doing the
5	energy modeling and we'll have better
6	feedback on that when that comes in.
7	MS. STILES: This is the last thing
8	and I promise it's quick. The last page of
9	the summary chart talks about a lead
10	innovative credit that we can get for
11	maintenance and best programs.
12	And being that we are all familiar with
13	this, I'm just wondering, it says at zero in
14	the post credit column.
15	I mean, the future of the County passed
16	laws about the use of County pesticides on
17	County projects.
18	Is there a way to get a credit for that?
19	Or has that been ruled out?
20	MR. LARSEN: That's a very good point
21	and something that we could look into. I
22	know that the County does have a good
23	pesticide policy. And we will definitely
24	consider that.
25	MS. VILORIA-FISHER: There was a

. 1	<u>-</u>
2	question because we are talking about
3	projects. We have a very tight policy on the
4	County.
5	MS. STILES: Just to clarify what
6	my question was.
7	MS. VILORIA-FISHER: I'm sorry.
8	MS. STILES: On the last page of the
9	summary chart it says that we can get
10	a lead innovation credit or one credit.
11	And then the section where we are
12	listing how much credit you will get, it's
13	zero. I thought that the County probably
14	already requires that anyway.
15	So you could probably get an extra
16	credit there. I just wanted to know why.
17	MS. VILORIA-FISHER: Couldn't that be
18	cheating again? We already have green
19	energy.
20	MS. STILES: I don't think so. It's
21	not setting off anything else.
22	THE CHAIRPERSON: We'll just take a
23	few minutes.
24	(Recess.)
25	(After recess continuing.)

2	THE CHAIRPERSON: All right, we can
3	reconvene. Can I have a motion?
4	MR. KAUFMAN: I'll make a motion
5	as follows. This is an unlisted action.
6	But I would like to have this
7	THE CHAIRPERSON: I'm sorry?
8	MR. KAUFMAN: I know it says type
9	one on there but I think it's unlisted.
10	MS. STILES: Jim is shaking his
11	head.
12	MR. BAGG: Right. If that's the case.
13	But basically under what criteria would it
14	become a type one?
15	MS. STILES: It may be the type of
16	action, it's a very low threshold.
17	MR. BAGG: It's a criteria for
18	any type statement. It's a different
19	thing.
20	MR. KAUFMAN: I'll try it again.
21	I'll say that this is a type one action.
22	But I would like to have a conditional
23	neg dec on this one, basically oriented
24	as follows.
25	That this won't obtain negative

Т	
2	declaration under SEQRA as long as
3	the lead status is met.
4	And we would also require once the
5	construction plans are finalized that
6	someone from DPW come back and certify
7	to us at one of our CEQ meetings that
8	the lead status has in fact been met.
9	Because as I understand it the
10	legislation, CEQ is one of the people that is
11	supposed to declare that lead status has
12	actually been met.
13	So we don't feel that we need the whole
14	crew and everything once you're coming in for
15	certification.
16	I think that's what we need. They
17	provide that lead status is met and we
18	need lead certification at a certain time.
19	MS. VILORIA-FISHER: Using the material
20	certification, we are not a certifying
21	agency. All I would like to do is when you
22	have filled the lead status, when you have
23	gotten the number of points that would
24	qualify it as a green building that you come
25	back to us so that we could see in fact which

2	of the components you have achieved.
3	Because I believe that if I didn't put
4	it into this particular legislation, I put it
5	in the second legislation which is that CEQ
6	reviews the lead components of the project.
7	Any project that is over a million dollars.
8	So we will give a conditional neg dec.
9	And then as I said, you don't have to bring
10	the whole written people here.
11	But we would like to take a look at it.
12	Because I think CEQ will by then,
13	Mr. Chairman, they have had a primer on lead.
14	Joe Schroeder can come up and review it.
15	And I'll make sure that everyone will
16	have the book that gives us how the
17	components of the lead program, how it's
18	divided, how the points are achieved, where
19	there are possible points.
20	And I think that it would be good for
21	everybody to be a little more prepared.
22	Some of us have been looking at it for a long
23	time.
24	And I think just out of fairness we
25	should all be able to give it a close look

1	
2	and say that we understand the project and
3	have looked at the project that way.
4	MR. LARSEN: I think that's a great
5	idea. And I would invite anybody on the
6	Board here who is interested in maybe coming
7	to one of our structure classes to get more
8	familiar with it. It's an open invitation.
9	MS. VILORIA-FISHER: Are there classes
10	on the green building?
11	MR. LARSEN: We're setting up some
12	classes, getting some classification on the
13	whole lead process.
14	MS. VILORIA-FISHER: I would love to
15	take advantage of that. I wanted to go to
16	the green building council last month.
17	It conflicted with my legislative schedule.
18	MS. SQUIRES: How would we know when
19	that's happening?
20	MR. LARSEN: I will definitely get a
21	memo out to everybody. I'll pass that
22	information along.
23	MS. SQUIRES: Thank you.
24	THE CHAIRPERSON: We have a motion
25	that has been made and we have a second.

1		1'
2	Mr. Kaufman made the motion.	
3	MS. VILORIA-FISHER: I'll second it.	
4	THE CHAIRPERSON: Type one. And then	
5	CND. Do we have a second?	
6	MS. VILORIA-FISHER: Second.	
7	THE CHAIRPERSON: And do we have any	
8	further discussion?	
9	MS. STILES: Let me explain the	
10	situation. It's debatable for the project?	
11	Possibly unlisted action, possibly a type	
12	one action.	
13	And I think to err on the side of	
14	caution, never say bad things. So I think	
15	it's fair for us to qualify it as a type one	
16	action.	
17	No one wants to deny the project or	
18	stop the project or anything like that so	
19	don't worry.	
20	But the conditions that we would like	
21	met is just to come back earlier. And if it	
22	was classified as an unlisted action, you	
23	cannot issue a condition as a negative	
24	declaration.	
25	We can go to neg dec. We don't want to	

	_	
2	have to do that. We want you to be able	
3	to move forward with project.	
4	So I think erring on the side of	
5	caution and making it a type one, a CND	
6	is just a negative declaration.	
7 .	So you get a neg dec as long as you	
8	meet the condition which is just to come	
9	back and show that you have certification.	
10	So I hope that clarifies it.	
11	MS. VILORIA-FISHER: Thank you.	
12	THE CHAIRPERSON: All in favor?	
13	(Unanimous aye.)	
14	THE CHAIRPERSON: Opposed?	
15	(None.)	
16	THE CHAIRPERSON: Motion carried.	
17	Now the CAC concern.	
18	MS. SQUIRES: I have a selfish issue	
19	request. I am going to be away in March.	
20	I don't know when you are proposing for the	
21	green building discussion.	
22	But I think it's a very significant	
23	issue that CAC who have been in attendance	
24	except for me and are not in attendance	
25	today I think it's the kind of thing that	

1	1	۱7
2	people should come and listen to. It's an

4	could it be in April?	
5	THE CHAIRPERSON: It's all right with me.

7	be in April and with a special impact.	
8	Maybe Jim as President of NYSACC, if you	
9	want me to add something that goes to the	
10	significant issue here.	
11	MR. BAGG: That's fine with me.	
12	But it really depends on when the Department	
13	of Public Works finalizes all these leads.	
14	MS. SQUIRES: I understand that.	
15	MR. KAUFMAN: We could arrange that.	
16	MS. SQUIRES: I'm talking about Vivian's	
17	presentation. Vivian suggested that we	
18	receive a presentation for someone	
19	specifically.	
20	And I was just asking for April and that	
21	we send this information out to CEQ with a	
22	strong reminder that this is a significant	
23	issue and they should be involved.
