Chairman's Report

- CHAIRMAN UPDATES THE COMMISSION ON THE FOLLOWING:
 - Comprehensive Plan work continues on Volume 1B, planning Volume 2;
 - Economic Development topics:
 - Reinvigorating SUPP, now known as SST (Submission and Status Terminal), which allows applicants to get real time tracking of permit applications – recent County Executive press conference and recent permit streamlining advisory group involving Commissioners Kelly, Roberts, Finn, Gershowitz and Whelan
 - Planning for possible “Sewer Summit 3” focusing on sewer funding options including TIF (Tax Increment Financing)
 - Transportation – possibility of urging the county to adopt “Complete Streets” legislation a many of the towns have done
 - Energy Efficiency Buildings and Renewable Energy:
 - Solar Permit Streamlining – Chair spoke at the Chicago Institute of Technology about SCPC’s solar initiative
 - “East End Wind Code” – presentation later this meeting by Katie Garvin from Southampton on near final draft
 - Geothermal effort will be next
 - Commercial Building Energy Efficiency Standards – Commissioner Berry, the Chair and County Sustainability Coordinator Dorian Dale had a call with NYS Director of Codes Ron Piester regarding rolling out optional new state code in Suffolk County
 - The Commission Guidelines were finalized and adopted at the last meeting.
 - Upcoming Commission meeting schedule, next meeting will be in Islip Town Hall.

Director's Report – Planning Director Sarah Lansdale was unable to attend the meeting, Chief Planner Andrew Freleng updated Commission on developments in the Division.

- Division of Planning and Environment has processed approximately 100 applications this past month pursuant to General Municipal Law 239.
- Staff has been working on a Transfer of Development Rights (TDR) Study. In part, staff will be inventorying all the TDR programs within Suffolk.
- Work continues on the Sagtikos Parkway and Commack Road By-Pass Study.
- Mr. Freleng noted the adverse impact of recent staffing cuts on the Division.
